- 5. Successful bidder should have to provide after sale, free service for a period of 6 months from the date of supply.
- 6. In case of any dispute, decision of the Executive Engineer (C) MSETCL, EHV CCCM Division, Sangli shall be final and binding on the contractor.
- 7. Rates quoted shall be inclusive of all the Taxes.
- 8. Validity of rate shall be applicable for 60 days from the date of opening of E-enquiries.
- 9. Income Tax, as per prevailing rates will be recovered from your bill.
