- 3) If registered under SSI, the Photo copy of the registration should be attached with the quotation.
- 4) Material supplied shall be guaranteed for trouble free and maintenance free performance for period of 1 year from date of receipt.
- 5) Material shall be provided strictly as per Schedule 'A'. If the material is not as per specifications, the quotation will be rejected.
- 6) Material should be delivered within 30 days from the date of the issue of order at MSETCL Executive Engineer, PAC Division, Sangli,
