### E- Quotation

Sealed and superscripted e- quotations are invited for the work as detailed in "Schedule- A" is enclosed herewith subject to following terms and conditions.

- 1) **Name of Work:-** Providing T-permit vehicle LMV/ MPV/ any Sedan car/ other suitable vehicle on hired basis for the Additional Executive Engineer (Civil) EHV CCCM Sub Division, Babhaleshwar.
- 2) The rates should be quoted on Firm Quotation basis (**Two Bid System only**)  
**(a) Compulsory Primary Documents in 1<sup>st</sup> Envelop:(Technical Bid)**  
Necessary document evidence of Vehicle Permit, Vehicle Insurance, Road Tax certificate PUC, RC Book, Fitness certificate and driving license, GST registration certificate PAN card, Experience certificate (self-attested) copies should be enclosed without fail. Any quotation not accompanied by the said documents shall be rejected and will not be taken in to consideration under any circumstances whatsoever.  
**(b) Documents in 2<sup>nd</sup> Envelop:(Price Bid)**  
Price bid only where in the rates should be quoted in figures as well as in words.
- 3) The vehicle should be in good running condition i. e tyre, all meter, cushion, viper, etc must be in working & good condition, also the date of manufactured of vehicle within 5 years before date of enquiry. However the preference will be given to latest model/ manufacture or certified car from concern end user as per CE/EHV PC (O & M) ZONE/NSK/T-20/No.0755 dtd.11.05.2019.
- 4) The vehicle along with Driver should present at duty Hours (09.00 to 19.00) or as per office requirement.
- 5) The Driver has to submit medical fitness certificate and has to maintain the vehicle diary daily.
- 6) During the vehicle on road if any problems related to vehicle arise it is owner's responsibility.
- 7) The quotation not confirming to specifications detailed in schedule "A" are likely to be rejected.
- 8) Income tax will be deducted at prevailing rate for every month.
- 9) The vehicle will be utilized on any day of the week and the same has to be made available with a short notice of the undersigned/ officer in charge. Further vehicle will be given off on any day without assigning any reason for which no charges will be paid for that day/ days.
- 10) The quotations should reach to this office **on or before dt. 06/03/2024 Up to 1.00 PM**
- 11) If the vehicle failed on the road, non use of hour will be counted for proportionate in the daily bill.
- 12) Execution of agreement on Rs. 500/- stamp paper is essential.
- 13) The following should be clearly mentioned on the sealed envelope "**Providing T-permit vehicle LMV/ MPV/ any Sedan car/ other suitable vehicle on hired basis for the Additional Executive Engineer (Civil) EHV CCCM Sub Division, Babhaleshwar**" with EMD of Rs. 100/-.
- 14) Executive Engineer reserves the right to reject any or all the quotations without assigning any reason therefore.
- 15) The period of order is 12 months from the date of placement of order. The driver should be free from alcoholic addictions. The average consumption of the vehicle given on hire basis should be


minimum for petrol- 16 Km/Ltr/ for Diesel- 18 Km/Ltr/ for CNG- 21 Km/Ltr. will be supplied/ provided by company. As per CE/EHV PC O&M Zone/NSK/T-20/226, dt. 29/01/2024 (Vehicle enquiry for AGM (HR)).

- 16) The contract can be terminated by the authority at any time, without assigning any reason by giving one day advance notice.
- 17) Deductions any amount or amounts which become payable by the contractor to the purchases under a particular contact may be deducted by the purchaser from any amounts/ amount due for becoming due by him to the contractor under the same or any other contact with this office.
- 18) Order value limit to each month **Rs. 50000/-** (including fuel, Hiring charges & Taxes).
- 19) In case of failure of vehicle either on tour or at Head Quarter the vehicle owner shall make alternate arrangements at owner's cost and if you fail to make such arrangements, department shall make the same at your risk and cost.
- 20) You will be fully responsible for GST on your contribution.
- 21) GST registration certificate is required. If the agency is not GST registered then GST will not be payable to unregistered agency/ vendor as per GST rules. In such case the agency/ vendor has to give undertaking that his annual turnover is less than the condition of non registration.

**Note:-**

- 1) The average consumption of the vehicle given on hire basis should be petrol- 16 Km/Ltr/ for Diesel- 18 Km/Ltr/ for CNG- 21 Km/Ltr Irrespective of actual average of the vehicle. If the average consumption in less, the Proportionate amount will be deducted from your bill.
- 2) Only diesel and road tool tax will be supplied by the MSETCL.
- 3) The normal duty hours will be from 09.00 Hrs to 19.00 Hrs. on every working day. However per day rate will be treated for 10 Hrs: and no nay extra amount will be paid towards halting charges etc.
- 4) The expediture incurred on driver such as salary, O. T, T. A, D. A etc. is to be born by you and nothing extra shall be payable to you or driver.
