a) **Statutory documents to established Eligibility:** The agency shall specifically ensure compliances various laws at including following laws/ Acts, and their enactments/ amendments/ modification, if any.

1. The Employee provident fund act, 1952
2. The Bombay shop and Establishment Act, 1948
3. Any other relevant Act/ Rules in force in application to this tender.

b) The bidder shall submit the following registration details of regulatory authority/ departments.

1. Current valid copy of registration under Shop & Establishment Act.
2. Current valid copy of GST registration.
3. Professional tax certificate.
4. Current valid copy of PAN/ TAN as the case may be.
5. Income tax return for the last 03 financial year.

c) **Work order copies and Experience Certificate** during last 5 years ending last day of month previous to the one in which application are invited should be either of the following.

The bidder should have experience of successfully completed similar works amounting to 60% of the estimated cost in maximum 3 orders during last 05 years ending last day of month previous to the one in which applications are invited. Experience of having successfully completed similar works amounting to 80% of estimated cost in single order or 50% of estimated cost in two order or 40% of estimated cost in three orders. **Experience certificates for successful completion of work along with work order** are required to submit for qualification of the bidder. The bidder should submit the experience only of State Govt. / Central Govt. / Semi Govt. / or Reputed Transmission Licensee. Experience certificates shall be signed by the officer **not below the rank of Executive Engineer**

- d) **Turnover:** Average Annual financial turnover certified by Chartered Accountant, during the last 3 years duly tallied with Profit & loss Account of corresponding years, ending 31st March of the previous financial year, should be at least 50% of the estimated cost.
- e) **Net worth:** Bidder should have Net-Worth not less than 20% of tender estimate. The certificate from the Chartered Accountant stating net worth shall require to be submitted along with the tender document.
- f) Details of T&P required executing the work
- g) No House accommodation will be provided. You will have to make your own arrangement.
- h) The contractor will solely responsible for any compliance of statutory obligation under shop & establishment Act, Labor contract Act, Minimum wages Act, Work man compensation Act, PF Act etc., the relevant Acts & rules in force.
- i) Accident :- You will be responsible for any accident either fatal / non fatal occurred to your person or any other persons due to mistake of your persons, during the course of work, the compensation arising due to this is to be borne by you on your risk, cost & responsibility.
- j) **GENERAL:** - The undersigned reserves the right either to accept or reject any or all quotations without assigning any reasons.
- k) **Security Deposit:** - 10% of Order value, Security deposit in cash/ DD should be deposited to this office within 7 days from the receipt of the work order.
- l) The work order amount is limited to Rs. 1,50,000/-(Inclusive of all taxes & L.Cess)
