Sealed super-scribed quotations duly quoted are invited for the work of providing of 1 No. LMV (car with A/C) Taxi permit Vehicle Maruti swift desire or equivalent along with Driver on hired basis for Executive Engineer, Nanded under PAC Division Nanded as per the scope of work as per schedule "A" start from **Dt 07.03.2024 to Dt. 13.03.2024 UP TO 17:30 Hrs.** on your letter head along with supporting documents. The quotation received after due date will not be considered. This office will not be responsible for any postal delay. Quotation will be opened on 13.03.2024 if possible.

The rate should be offered in Schedule "B" attached herewith.

The Quotation shall be accompanied with the following documents as mentioned below:

- A. The rate shall be quoted on firm quotation basis.
- B. Attested copy of valid Registration of the vehicle issued by R.T.O.
- C. Valid Copy of registration under Bombay Motor Vehicles (BMV) Tax Act, 1958 and fitness Certificate of vehicle under Motor vehicle act 1988.
- D. Valid copy of Recent Pollution Test Certificate (PUC).
- E. Valid copy of Motor vehicle comprehensive Insurance duly renewed.
- F. Attested copy of Taxi Permit certificate. The vehicle on hiring should have Valid "Taxi" permit issued by concerned authorities.
- G. Driver should possess the valid Transportation License's authorized by RTO. Attested copy of valid driving license of the driver shall be submitted after award of contract.
- H. Valid copy of PAN Card of authorized Signatory.
- I. Attested copy of GST Tax Registration (GSTIN number), if applicable.
- J. Shop act registration
- K. An agreement on non-judicial stamp paper of Rs.500 in between agency and vehicle owner shall have to be submitted if the order is awarded to the agency.

The Terms and conditions are as follows: -

1. **Period of Work:** - From date: 01.04.2024 to date: 31.03.2025
2. **Value of Work:** -Value of work is limited to Rs. 475380.00 (In words: - Rs.Four lakh seventy five thousand three hundred eighty only) inclusive of all taxes. If nothing is mentioned about taxes the quoted rate will be treated as rate inclusive of all taxes.
3. The fuel consumption for the vehicle will be considered @ 15 Kilometer/Ltr with A/C. The cost of fuel will be borne by the MSETCL.
4. Vehicle should be in good running condition, in all respects.
5. Vehicle should be in good running condition. NO extra charges will be paid for vehicle driver, oil ,maintenance , other taxes , duties etc.
6. Responsibility of comprehensive insurance , PUC , Taxi permit , fitness Certificate & RTO formalities will be of agency only.
7. The quotations should be properly, sealed and super scribed with the Envelopes "Quotation for providing of Taxi Permit Vehicle along with Driver on hire basis for Executive Engineer, Nanded under PAC Division Nanded".
8. If work is allotted, the agency shall have to pay Security deposit i.e. 5% of order value, without any interest within 7 days from the date of allotment of work in terms of Cheque/DD/FDR in favor of the Executive Engineer, EHV O&M Division Nanded. If you fail to execute the work in full or part security deposit will be forfeited.
9. An agreement has to be signed with MSETCL regarding abiding with all the terms and conditions of the work on a non-Judicial stamp paper of Rs. 500/- if work is allotted to you.
10. An alternate taxi permit vehicle shall immediately be provided in case of any breakdown to the vehicle or any other reason, otherwise per day rent or actual expenses incurred on hiring of similar vehicle from any other party, whichever is higher will be recovered from the RA bill/security deposit.
11. There will be weekly offs on Sunday for which no payment will be made however if the vehicle is used by the undersigned on weekly OFF the payment will be made at the rate agreed at the time of work allotted.
12. It is mandatory for all vehicle owners to use FASTag which should be linked to the registration number of your vehicle. The toll payment which will be deducted from your fastag account will be reimbursed after claiming with monthly bill. You have to provide statement of toll payment from the concern FASTAG account for claiming the toll charges.
13. Driver employed for the hired vehicle should possess valid driving license issued by the Competent Authority of the government & should be sufficiently experienced to drive on the road including state & National Highway. The Driver should know reading either Marathi / Hindi.
