

# INVITATION FOR BID (IFB)

## (LOCAL COMPETITIVE BIDDING)

- 1.0** The Maharashtra State Electricity Transmission Company Limited Mumbai, herein after referred to as the 'Owner' (MSETCL) invites bids through SRM e-Tender in TWO bid system (Techno-commercial Bid & Price Bid) from eligible bidders in India having executed similar projects in transmission sector on turnkey basis for work of **empanelment of Surveying Agencies for the work of preliminary, detail survey as & when required for various projects for system strengthening and for shifting/height raising/ reorientation of EHV lines for Highway crossing/ railway crossing & ORC consumers etc. under jurisdiction of MSETCL, Maharashtra.**

**2.0 Scope of Work :-**

**SRM e-Tender No. CE/Projects/Pre-T/2023-24/RFP-1 (RFx No. 7000030534)**

**3.0 QUALIFYING REQUIREMENT**

In order to be qualified for award of Contract, the bidder will be required to satisfy the following minimum criteria, which will take precedence over any qualifying requirements that may be stated in the specifications or elsewhere in the bidding document. The bidder shall satisfy the following conditions:

<b>3.1</b>	<b>STATUTORY QUALIFYING CRITERIA</b> <b>Statutory Licences/Registration</b>
3.1.1	The bidder should have a <b>valid Civil Contractor's License</b> .
3.1.2	The lead bidder should be registered under <b>GST</b> . The Bidder shall submit the copy of GST returns of last 01 (One) year if applicable.
3.1.3	The lead bidder should be registered under P.F. Act. (if Applicable)

<b>3.2</b>	<b>TECHNICAL QUALIFICATION CRITERIA</b>
3.2.1	<p>The bidder should have executed the survey work of 132kV or above transmission line at least 100 circuit Kilometre cumulatively during last 07 (Seven) years in MSETCL or any power transmission utility.</p> <p style="text-align: center;"><b>OR</b></p> <p>The bidder should have executed the survey work of EHV underground cable at least 10 circuit Kilometre cumulatively during last 07 (Seven) years in MSETCL or any power transmission utility.</p>
<b>3.3</b>	<b>FINANCIAL QUALIFYING CRITERIA</b>
3.3.1	The <b>Average Annual Financial Turnover</b> of the bidder during the last three Financial Years shall not be less than <b>50 Lakhs</b> . The bidder should submit the Turnover certificate duly certified by Chartered Accountant along with UDIN (Unique Document Identification Number).
3.3.2	The Bidder should have <b>Net worth</b> (which is defined as “Equity share capital + Reserves – Revaluation reserves – intangible assets – Miscellaneous expenditure to the extent not written off and carry forward losses”) shall not be less than <b>5 Lakhs</b> for last Financial year duly certified by Chartered Accountant along with UDIN (Unique Document Identification Number).
3.3.3	The bidder shall be required to furnish Bid Security Deposit (BSD) for an amount of <b>Rs.5,000/- by online mode</b> .
Note	The duly audited, verified & certified figures from Chartered Accountant will be considered for Annual Turnover & Net worth.

#### **Important Points for Bid Submission:-**

- 1 The proposals are to be submitted in two parts viz. Techno-commercial Bid and Price Bid.
- 2 Prepare your Techno-commercial Bid documents in accordance with the instructions provided in the tender documents.
- 3 Prepare your Price Bid separately, ensuring all pricing information is accurate and compliant with the tender requirements. Do not mention prices in any other document.
- 4 Upload Techno-commercial Bid documents On-line under “Notes and Attachments” tab under "Technical bid attachments". This is valid only for Technical Bid submission and not for Price Bid submission
- 5 Upload Price Bid separately in “Attachments” tab. **[Refer screenshot attached in tender document for more clarity]**

#### **4.0 General Points:-**

- 4.1 The prices to be quoted against this IFB shall be in Indian Rupees only.
- 4.2 The price should be quoted on a lump sum basis inclusive of all taxes and duties but **exclusive of GST**. The GST, as applicable shall be paid separately.
- 4.3 The empanelment of agencies will be treated as works contract in totality.
- 4.4 The bidder has to submit the offer (i.e. Price Bid) in the prescribed format attached in the bid document as **Annexure –I (i.e. Budgetary Offer)**.

- 4.5 For Evaluation of the Tender, the total price of survey work **excluding GST** be considered.
- 4.6 Submission of bids with unrealistic rates, the MSETCL reserves the right to reject the bid summarily.
- 4.7 The notice of empanelment will be issued to eligible bidders on the average price received from qualified bidders for survey work, **excluding GST**.
- 4.8 Based on terms & conditions of this tender the field officials will place a work order at derived prices, as & when required.
- 4.9 Price variation shall not be given. The price quoted by the bidders shall be FIRM throughout the period of contract including any extension thereof.
- 4.10 A complete set of documents can be downloaded by the bidder from MSETCL's SRM E-tendering website <https://srmetender.mahatransco.in/> The cost of bidding documents should be paid online before the date of bid submission and the screen shot of successful payment transaction shall be uploaded with bid documents being submitted by the bidder.
- 4.11 The rates shall be finalized on **Average of quoted price of qualified bidders**, exclusive of GST. 100% GST payment shall be made against invoice submission. All other provisions of the tender remain in full force and effect, other than any provision that conflicts with the terms and spirit of this tender, which shall be deemed to be amended appropriately in order to be consistent with clause.
- 4.12 MSETCL reserves the right to derive prices for empanelment based on market research, industry standards, and other relevant factors. These derived prices may be used as a reference point or benchmark during the evaluation process. MSETCL retains the discretion to accept or reject bids based on the derived prices and other evaluation criteria outlined in the tender documents. Bidders are advised to consider this clause when submitting their proposals.
- 4.13 It may please be noted that the taxes / duties will be paid / reimbursed as per actual OR as stated in price break-up statement whichever is lower on submission of valid documentary proof. In case of any variation in statutory taxes/duties/levy or any new existing tax/duty/levy is revoked by the Government, the same shall be passed through either side. In certain cases production of valid documentary proof may be brought for.
- 4.14 The bidders are requested to submit their financial documents (Turnover & Networth certificate) duly audited, verified & certified figures from Chartered Accountant and same should be generated with UDIN number. So, the same can be verified on <http://udin.icai.org>.

- 4.16 The new bidders are requested to complete the contractor registrations for SRM e- Tendering with MSETCL as per the procedure prior to the date of submission of the tender documents. The bids of only registered main/lead bidders will be entertained.

2. The contractor should submit their bids online well in advance within the due date & time. The scan copy in respect of online payment of EMD and SRM E-tender fees should be submitted online along with the bid.
