TERMS AND CONDITIONS:-

- 1. The Rate shall be quoted on firm quotation basis.
- 2. The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR Hiring of MMV vehicle i.e. Tata 407/ Bolero Camper or equivalent vehicle along with driver for 400 kV Line Maintenance Sub Division Kumbhargaon, under 400 kV R S Division Kumbhargaon, Nanded. (Enquiry No. _____ be quoted).
- 3. **Quoted Rate:** The Rate shall be quoted on firm quotation basis, for the particulars mentioned in Schedule "A". Taxes and charges should be mentioned clearly. If not mentioned, rate quoted will be considered as inclusive of all taxes.
- 4. **Important Dates:** Quotations invited from **14.03.2024 from 10:00 Hrs**, so as to reach this office up to **20.04.2024 up to 17:00 hrs** and the same will be Opened on the same day, if possible. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
- 5. Service Tax: Service Tax will be paid & recovered, as per rules.
- 6. **Period of Contract:** The period of vehicle will normally be 365 days from the date of engagement of vehicle or Upto the total expenses limited to order value of condition no.7, however if MSETCL Departmental vehicle allotment made by higher office, then the hired vehicle will be discontinued by giving 15 days' notice period.
- 7. **Order value:** Order value is limited to **Rs.5,38,375.0/-** (In Words: Rs. Five Lakh Thirty Eight Thousand Three Hundred and Seventy Five Only), inclusive of all taxes.
- 8. **Payment:-** The payment will be made on monthly 'RA' bill basis. Payment will be made after submission of that bill, the payment against this contract will be effected by MSETCL within reasonable time as per funds availability.



- 9. **Security Deposit:-** Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD to the office of the Executive Engineer, 400 kV R S Division Kumbhargaon, Nanded from the date of issue of order.
- 10.**Signing of Contract:** Agreement contract between MSETCL authority & you should be carried out on Rs.500 bond paper within 7 days from the date of receipt of the work order. You will have to borne the charges for agreement bond.
- 11. **Validity of Offer: -** The offer should be valid for our acceptance for a period of 45 days from the Due date of same.
- 12.Documents required: The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
 - a. Valid Shop Act registration
 - b. Valid GST registration no. (Optional)
 - c. Valid PAN No.
 - d. Vehicle Registration Certificate
 - e. Vehicle Permit Goods Permit
 - f. Driver with Valid Driving license
 - g. Valid Vehicle Insurance
 - h. Valid PUC certificate
- 13. No extra charge will be paid for vehicle driver, oil & other taxes & duties etc. only Toll tax is paid by MSETCL.
- 14. The fuel (Diesel) charges to be borne by MSETCL with the condition that the vehicle should give minimum 8 Km / Ltr and manufacture of vehicle provided should not be prior to year 2016.
- 15. The responsibility of comprehensive insurance, PUC & RTO formalities will be with vehicle provider.
- 16. Agency to submit the quotation along with all necessary vehicle documents.
