TERMS AND CONDITION:-

- 1. <u>DUE DATE</u>: The quotations complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dtd. 21.03.2024 up to 17:00 Hrs** positively in the name of undersigned. The quotation must be forwarded in sealed envelope duly superscripted with all details i.e. **Enquiry No & Date, due date and Quotation for**. The quotation must be written with ink or typewritten, any scratching or over writing must be avoided.
- 2. <u>ENQUIRY FEES:</u> The vendor has to pay Enquiry Fees of Rs. 100/- in cash to 400kV RS Division Khadka against enquiry Fees & copy of receipt must be attached with quotation.
- 3. <u>SCOPE OF WORK</u>:- As scope of above subjected work is Limited to Rs. 3,85,907.2/-(Including GST and all taxes)
- **4. QUOTED RATES:-** The rates are accepted on firm quotation basis including drivers expenses, oil (Lubricants) day to day maintenance & repair nothing shall be paid extra. The rates are valid for twelve month from the date of engaging the vehicle.
- 5. <u>Income Tax</u>, <u>Labour Cess & GST</u>:- If applicable, as per rules will be deducted from your bills.Income Tax, labour Cess & TDS GST will be deducted at source from your bill as per government rules. GST @ 18% will be paid extra on cost of work or as per MSETCL rule are applicable as per prevailing rules of Govt. However, all any other local taxes applicable will be borne by you at your own cost. Also 1% Labour Cess on the total value of bill i.e. (Including GST) will also be deducted from the bill.

6. SECURITY DEPOSIT:-

10% of the value of the contract is to be paid (for the offers received below the estimated cost of the tender, the amount of performance security deposit / BG shall be applicable as per guidelines issued vide Annexure-A of reference letter No. MSETCL/CO/CE/TR.O&M/SE-II/EE-VII/No. 2064 Dtd. 16.02.2024) in the form of FDR/D.D./B.G of any Nationalized/scheduled Bank in the name of **The Executive Engineer**, 400kV Rs Dn. Deepnagar, BSL-II.

No interest will be paid on this amount and this will be refunded after satisfactory execution of works /guarantee period, whichever is later. The Security Deposit will be returned to you without any interest after 90 days of successful completion of the Contract Period and after completion of Contractor's other obligations under the Contract.

7. AGREEMENT & STAMP DUTY:-

- a. The successful Contractor has to execute an Agreement with **The Executive Engineer**, 400kV RS Dn. Deepnagar-Bhusawal-II within 14 days after receipt of letter of intimation; the work order will be only issued after executing the Agreement & submission of security deposit @ 10 % to this office.
- b. The Contract Agreement shall be executed on non-judicial stamp paper amounting to **Rs. 500** (**Rs. Five Hundred only**) as per the Clause 34 of Mumbai Stamp Duty Act 1958. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.
- **8.** <u>VALIDITY OF OFFER:</u> The offer should be valid for a period up to **12 months** or to the exhaust of the order value from the due date of opening of Quotation.
- **9.** WORK SUPERVISION OFFICER:- The work shall be supervised by the Executive Engineer 400kV Deepnagar-Bhusawal-II or his representative and utilization of vehicle will be as per instructions of EE 400 KV RS Dn. Deepnagar-Bhusawal-II only.
- 10. <u>WORK COPLETION PERIOD:</u> The period of completion of work for hiring of vehicle shall be 12 Months or till the exhaust of complete work order value from the Date of Engaging of vehicle.
- 11. The Registration of vehicle should be within 07 years from the date of this enquiry & the colour of vehicle should be white/off white or similar.
- 12. Necessary essential documents required for hiring of vehicle to be attached with quotation:

 - 3. Copy of Comprehensive Insurance certificate,

 - if Applicable and all relevant documents should be obtained from RTO (the same should be valid during the Contract period and maintained continuous by you, you have to take necessary permission if Required from RTO Authority for hiring purpose)
- 13. <u>SUBMISSION OF INVOICE & PAYMENT:</u> Monthly Bill in duplicate should be submitted in the name of the Executive Engineer 400 KV RS Dn. Deepnagar-Bhusawal-II to this office along with **Vehicle diary/Log book Xerox copy signed by EE 400 KV RS Dn. Deepnagar-Bhusawal-II,** and After due audit & verification, Executive Engineer, 400 kV RS Deepnagar-Bhusawal-II, shall effect the payment. Payment of Bill will be made as per the availability of funds at 400 kV RS Deepnagar- Bhusawal-II. However, the payment will be made as per actual measurement & as per the actual work done. Please quote You're PAN. No & GST no. on your quotation /Bill otherwise, Taxes as per rules will be deducted from your bill.
- 14. A vehicle diary/Log book should be maintained separately by agency for recording Km reading, fuel, Time & date etc. It should be signed daily by the concern incharge i.e. The Executive Engineer, 400 kV RS Deepnagar-Bhusawal-II.
- **15.** <u>AVERAGE</u>:- Only diesel will be provided by MSETCL at the minimum assured average run of **17 KM/Ltr**. If it goes below than that, the vehicle owner should bear the additional expenses on his account & same changes will be deducted from monthly bill.

- **16.** <u>LIQUIDATED DAMAGES / LOSS DUE TO THEFT: -</u> Any damage or loss to M. S. E T. Co. Ltd's roperty. due to your employees' negligence during the course of work shall be on your part and same shall be recovered from your bill based on the report of findings from Police Department.
- 17 <u>ACCIDENT LIABILITY: -</u> If any accident occurs during the work, the complete responsibility of the accident will be of Contractors. The MSETCL shall not pay any type of compensation for any type of accident.
- 18. <u>PENALTY:-</u> If the hired vehicle is not made available on any working day/day without convincing reason or without intimation, in that case the amount of Rs. 1000/- will be deducted from that month bill for each occasion of non-availability of vehicle.
- 19. If the performance and services given by the hired vehicle & Driver is not found satisfactory, the Contract will be terminated without giving any notice at cost and risk of person contracting the vehicle and security deposit paid will be forfeited.
- 20 The hired vehicle must run on all types of roads. The condition of all tyres fitted to the vehicle must be in good condition. Good and serviceable Stephaney should be provided in the vehicle.
- **21.** The vehicle driver must wear white colour uniform as per Circular No. CE/EHV/PC/O&M/Zone/NSK/ HR/ F-296/No. 959 Dtd. 21.05.2019.
- 22. In case of failure of this vehicle, you will have to provide the vehicle on the same terms & conditions.
- 23. The Company will not undertake any responsibility if the instruction RTO formalities are violated by you.
- 24. The vehicle is to be driven by the driver to be provided by the contractor who must have valid license for driving the vehicle. The driver shall strictly observe all the provision of M.V. act 1939 amended up to date. The driver must be polite, punctual in attendance & free from illicit habits, throughout the contract period.
- **25.** A very good experienced driver is to be provided by you at your cost Driver Should not have any Criminal record and no fir should be registered on him. Driver should not found any type of alcoholic drunk during working hours, if found undersigned reserve the right to cancel this order or discontinued the vehicle.
- **26.** All terms and conditions as per company's rules shall be applicable to this contract also. And the vehicle will be hired for period of 12 months or till receipt of departmental vehicle whichever is earlier.
- **27.** The right to add/alter/modify/ order partly or fully at any stage or to cancel without assigning any reason thereof is reserved by the undersigned.
- 28. The undersigned reserves the right to reject any or all quotations without assigning any reason thereof.
- **29.** In case of difference opinion, about interpretation of terms & conditions between Owner/Agency and MSETCL the decision of the order placing authority will be final and binding on the Owner/ Agency.
- **30.** Any dispute arising under thereof or in connection with this contract shall be subject to jurisdiction of Bhusawal court only.
