- 1. Scope of work: As per Schedule "A".
- 2. The quotation should be sent under sealed cover duly super scribed as QUOTATION Hiring of Air conditioned vehicle i.e. Maruti Suzuki D'zire or Equivalent Sedan with driver for the movement of Executive Engineer 400 kV RS Division Kumbhargaon, Nanded. The quotation complete in all respects i.e. Offer rates should be filled in given work Schedule "A" format copy, Duly signed, sealed & super scribed, along with covering letter of bidder/agency with above mentioned subject. (Enquiry No. _____ be quoted).
- 3. Quoted Rate: The Rate shall be quoted on firm quotation basis, for the particulars mentioned in Schedule "A". Taxes and charges should be mentioned clearly. If not mentioned, rate quoted will be considered as inclusive of all taxes.
- 4. Important Dates: Quotations invited from 15.03.2024 from 10:00 Hrs, so as to reach this office up to 21.03.2024up to 17:00 hrsand the same will be Opened on the same day, if possible. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
- 5. Income Tax:Income Tax will be paid & recovered, as per rules.
- 6. **Period of Contract:** The period of vehicle will normally be 365 days from the date of engagement of vehicle or Upto the total expenses limited to condition no.7. However if MSETCL Departmental vehicle allotment made by higher office, then the hired vehicle will be discontinued by giving 15 days' notice period.
- 7. **Order value:** Order value is limited to Rs. 4,73,770.00 (In Words: Rs. Four Lakhs Seventy Three Thousand Seven Hundred & Seventy Only) Inclusive of all Taxes.
- 8. **Payment:-** The payment will be made on monthly 'RA' bill basis. Payment will be made after submission of that bill, the payment against this contract will be effected by MSETCL within reasonable time as per funds availability.
- 9. Security Deposit:- Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD to the office of the Executive Engineer, 400 kV R S Division Kumbhargaon, Nanded from the date of issue of order.



- 10. **Signing of Contract:-** Agreement contract between MSETCL authority & you should be carried out on Rs.500 bond paper within 7 days from the date of receipt of the work order. You will have to borne the charges for agreement bond.
- 11. Validity of Offer:- The offer should be valid for our acceptance for a period of 45 days from the Due date of same.

The fuel (Diesel/Petrol) charges to be borne by MSETCL with the condition that, the Diesel vehicle should give minimum average of 14 Km/Ltr with Air condition& 16 Km with Non Air condition use, while Petrol/CNG vehicle should give minimum average of 16 Km/Ltr/Kg with Air Condition& 18 Km/Ltr/Kg for Non Air condition use. Manufacture of vehicle provided should not be prior to year 2018.
- 15. The responsibility of comprehensive insurance, PUC, Taxi permit & RTO formalities will be with vehicle provider.
- 16. Quotation submitted along with all necessary vehicle documents.
