After due date and time , the quotation will not be received .Further , if any holiday declared by MSETCL at due date then due date before date will be the due date of quotation submission . No further compliant will be entertain by this office .
2. On quotation envelope , clearly mentioned the word “ QUOTATION” and subject will be “ Work of Tree cutting /trimming branches in 400kv RS Karad Substation under 400kv RS Dn.Karad . “ . The reference will be enquiry no.
3. The quotation will be opened after receiving the minimum three nos. of quotations and further that , minimum 3 nos. Of quotation should be submitted the required valid documents, otherwise , the enquiry will cancel.
