
- 1) **Destination of Work** - EHV Projects Division, Kolhapur & Subdivision offices, Bapat Camp, Kolhapur.

- 5) **Payment** - Payment will be released within 15 to 30 days considering availability of funds. No advance payment will be given.
- 6) **Security Deposit** - You have to pay 5% S. D. on ordered amount or will be deducted from your bill.
