E-enquiry is invited for above work as per the Schedule 'B' attached so as to reach this office on or before **17.05.2024** up to **13.00 hrs.** The enquiry will be opened on the same day if possible.

TERMS AND CONDITONS:

1. Work is to be done at **400 kV S/S Lamboti, Dist Solapur.**
2. Work is to be completed within **12 months** from the date of handing over of site or up to exhaustion of P.O. amount.
3. E-enquiry mentioned in Schedule 'B' are approximate and payment will be made on actual quantities of the work executed.
4. Payments will be made in R.A. bills or only first and final bill at the discretion of Engineer in charge as per availability of funds.
5. Our rates are inclusive of all GST will be recovered from your bill as per Government rules at prevailing rates.
6. Rates quoted should be inclusive of all T & P labour etc.
7. Work is to be carried out strictly as per the standard specification and as directed by the Engineer in charge. Mode of measurements will be as per P.W.D. practice.
8. In case of any dispute, the decision of the Executive Engineer (C) Solapur will be final and binding on the contractor.
9. If any damages occur to the Company's property, during execution, contractor will have to make them good at his own cost.
10. Agency has to attach Xerox of PAN Card, Registration Certificate, EPF certificate, G.S.T. certificate etc. and all necessary documents along with the e-enquiry.
11. Income tax as applicable as per Government rules at prevailing rates on basic amount of bill will be recovered from your bill, in case the ordered value exceeds Rs. 5000/-.
Work contract tax and will be deducted as per Govt. rules.
12. All terms and conditions as per the Company's rules including those mentioned in the booklet, Tender and contract for works are applicable in this case also.

13. Right to reject any or all quotations without assigning any reasons is reserved by the undersigned.
14. Contractors will have to pay **Rs. 3,500/-** as E.M.D. Quotations without EMD are liable for rejection. The E.M.D. is to be paid by Cash only.
15. Contractors are requested to visit/inspect the site before submitting their quotations.
16. Contractors will have to pay Rs. 10% S.D. on value of the work order in the form of Bank guarantee or F.D.R of Nationalized Bank prior to starting of work.
17. The rates quoted should also be written in words.
18. Over writing, corrections if any shall have to be initialed by the contractor.
19. Contractors will have to enter into agreement bond on stamp paper of Rs. 500/- before the start of work.

20. ADDITIONAL SECURITY DEPOSIT-

In case, contractor's offer is less than 90% of the estimated cost, additional security deposit in the form of F.D.R./Bank Guarantee in Company Standard Proforma for a period of contract and for an amount equal to the difference of the contractor's offer and 90% of the estimated cost as stated above shall be paid along with the security deposit to be paid as per regular practice of 5% of work in the office of The Executive Engineer (Civil), MSETCL, CCCM Division, Solapur. The period of the additional security deposit shall be extended up to expiry of valid extension, if any, as directed by Engineer-in-charge. Non-submission of above additional security deposit will result into forfeiture of the E.M.D. The additional security deposit will be refunded in accordance with the clause of refund of security deposit.

21. Insurance for works and workmen:

An amount @ 0.5% of the estimated value is included in the estimate as per SSR 2022-23. As per Government of Maharashtra Resolution AIF-2183/CR/174/83ADM-5 dt.16.01.1984,vimasa-1098/pr.kra.28/98/shasan hami Dt.19.08.1998 and Vimasa 1011/pr.kra.15/Vima prashasan Dt. 29.04.2011, Contractors all risk(CAR)insurance or Transit cum Erection (TCE) or Erection all risk (EAR) insurance in respect of contract work awarded by MSETCL as principal to the contract work & workman's compensation insurance in respect of workmen engaged & deployed by the contractor to complete the work at the awarded work site is required to be obtained from the Director of Insurance, Government of Maharashtra, Gruh Nirman Bhavan (MHADA), 264, first floor, Opposite Kalanagar, Bandra (E) Mumbai 400051, under direct method or from insurance company i.e. M/S United India Insurance Co Ltd. or any other insurance company as approved by the Director of Insurance on Co- insurance cum servicing basis under indirect method (IRDA). Contractor shall obtain the policy as mentioned above from the insurance company i.e. from United Insurance Co Ltd entrusted by Director of Insurance, Govt. of Maharashtra or any other insurance company as mentioned above.

As per the directives of Govt. of Maharashtra letter No NMP1009/ Sankra39/NV 26 Dt 16.3.2009 it is to be noted that in case the insurance policy is not obtained by the contractors, the MSETCL shall recover two percent (2%) of contract value & deposit the same with Director of Insurance govt. of Maharashtra , Mumbai.

Such insurances shall be effected with an insurer and in terms of approved by the owner (which approval shall not be unreasonably withheld) and the contractor shall whenever required produce to the Engineer the policy or policies of insurance and the receipts for payment of the current premiums within 10 days from the receipt of P.O.

The contractor shall produce the Labour insurance policy. The same will be reimbursed to the contractor, if contractor fails to produce the labour insurance policy, the concerned Executive Engineer shall draw the policy. The amount Two Times amount of expenditure incurred for drawing the policy shall be recovered as penalty form the 1st R.A. bill of the contractor as penalty to the contractor.

If completion period of work is extended, then period of labour insurance must be renewed / extended as per requirement.
