TERMS AND CONDITIONS:

1. The EMD and Tender fees is to be paid online on the account of MSETCL through website <https://srmetender.mahatransco.in>. **Due Date- 11.06.2024 upto 10:00 Hrs.**
2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- Submit the performance /experience certificate along with order for supply of “*mid back chairs with writing pad*” at any Government /Private sector in india.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer or equivalent. The bidder shall also submit the copy of the work order mentioned in the experience certificate as testimonials.
- The bidder should be manufacturer or authorized dealer/channel partner of Manufacturer, if the bidder is authorized dealer/channel partner, then valid authorization letter from manufacturer shall be submitted along with bid.

Commercial Bid.

- PAN Card of the firm/proprietor as the case may be. Income Tax return for last one year.
 - Certificate of Registration for GST with latest paid Challan.
 - Shop Act License.
 - Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.
 - Net Worth of last 1 year duly certified by Chartered Accountant should not be less than 25% of estimated cost.
3. The Contractor rates should be in percentage (%) based on estimate cost.
 4. Rates should be valid for 120 days from the date of commercial opening of RFx.
 5. Rfx fee is Rs.118/- including taxes (Is nonrefundable).
 6. If the above documents are not applicable, then submit Eligible/ Non eligible documents list.

7. Income Tax will be deducted from contractor's bill, as per Govt. rules
8. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

9. **Scope of work: -**

Supply of 40 Nos. of Mid Back Chairs with writing pad and leather upholstery for Regional Training Centre, Padghe.

- 10) **Delivery Period:** - The time being essence of the contract, the supplier should strictly adhere to the delivery period. The delivery will be deemed to have been completed on the date of R.R. / on the date of receipt of material at stores in case of door delivery. A postal transit period of 7 days will be allowed from the date of issue of this order. The delivery period will be one Month from the date of the order.
- 11) **Quality of Work:** - The material should be supplied as per specifications mentioned in Schedule. The sample should be got approved from Executive Engineer, Regional Training Centre, Padghe or his representative for material before delivery.
- 12) **Dispatch Instructions:** - The material shall be dispatched and consigned to the Regional Training Centre, Padghe.
- 13) **Warranty:** - The Contractor will have to give a warranty/ guarantee for material supplied for the period as specified by the manufacturer/OEM of the material from the date of receipt of material at site/ work place as the case may be. The warranty certificate should be given along with the material. If the OEM warranty is less than One year, the bidder shall give warranty of at least four years from supply of material.
- 14) Before issue of work order, the contractor will have to pay security deposit of @ 10% of the order value on any scheduled, private or nationalized bank **either by-**
 - i) **F.D.R. or D.D.** drawn in favor of MSETCL, Padghe **or by RTGS**
 - ii) **B.G.** drawn in favor of MSETCL, Padghe.
