- 1) **Due Date:** The quotations complete in all respects should be submitted online on or before **12.06.2024**; **14:00 Hrs.** positively.
- 2) **Scope of Work:** work of Anti-termite, Anti-reptile & Rodent control treatment at 400KV RS Dhule & 220KV Old Dhule S/s. under 400KV R.S. Division Dhule.
- 3) **Quoted Rates:** The rates quoted should be including of all taxes, charges, etc.
- 4) **Security Deposit:** The successful bidder will have to pay an amount equivalent to **10%** of Contract value towards S.D. to the office of the Exe.Engineer,400KV R.S. Dn. Dhule within 7 days from the date of receipt of LOI which is refundable after satisfactory completion of guaranty period.
- 5) **Agreement:** Agreement contract between MSETCL & successful bidder should be carried out on Rs. 500/- bond paper within 7 days from the date of receipt of LOI. Successful bidder will have to borne the charges for agreement bond.
- 6) **Validity of Offer:** The offer should be valid for our acceptance for a period of 180 days from the due date of this SRM E-Enquiry.
- 7) **Technical Qualifying Criteria:** The rate offer must be accompanied with following documents by vendor:

<u>Technical bid (Qualifying Requirement):</u> Bidder should upload the following digitally scan copies of original documents / certificates online in 'note & attachments' tab in RFx.

1. Statutory Qualifying Requirement/Criteria:

- i. The Bidder should have a valid registration under <u>Bombay shop & Establishment Act 1948/</u> Small Scale Industry Act / Company(Factory) Act - Proof thereof.
- ii. The Bidder should be Register under <u>Goods & Services Tax (GST) Act</u> Proof thereof.

Note: The original colored scan copy should be uploaded as bid documents in support of statutory qualifying criteria i.e. statutory licenses/registration. The attested / notarized photo copies of the same will not be entertained.

2. Technical Qualifying Requirement/Criteria:

- i. Valid License to Sell, Stock OR Exhibit for Sale OR Distribution of Insecticides for the purpose of Pest Control from Agriculture Development Officer.
- ii. The bidder should have in last 05 years experience of "Similar work" for amounting as follows;
- a. **One** completed work mentioned above having costing not less than the amount equal to **80%** of the estimated amount, OR
- b. **Two** completed works mentioned above having each costing not less than the amount equal to 50% of the estimated amount, OR

- iii. Work completion certificate along with Work Order Copy of Similar/related type of works as a Proof of Experience of any Govt./Semi-Govt./Private sector utilities. Experience Certificate is essential from competent authority not below the rank of Executive Engineer.
- iv. The owner reserved the rights to accept / reject the Bid.
- v. If validity of any license / certificate expires during order period, you will have to renew the same and submit the copy to this office.

3. Financial Qualifying Requirement/Criteria:

- i. The Average Annual turnover of the bidder during last 3 financial years should be not below than 60% of estimated cost.
 - The bidder should submit the certificate of turnover through <u>Unique Document Identification Number (UDIN)</u> duly certified by Practicing Chartered Accountant for preceding (last) 03 financial years on the basis of audited financial statement
- ii. The bidder should have a "Net Worth" (which is defined as "Equity share capital + Reserves Revaluation reserves Intangible assets Miscellaneous expenditure to the extent not written off and carry forward losses") of not less than 25% (Twenty Five percent) value of estimated cost of tender offered. The bidder should submit the statement of Net Worth duly certified by Chartered Accountant for the <u>last financial year</u>.

The duly audited, verified and certified figures from chartered accountant will be considered for annual turn over and net worth. The provisional certificates (if any) will be not be entertained.

4. Other Mandatory Documents For Valid Bid:

- i. The bidder should complied/meet MSETCL's required technical specifications mentioned in Annexure-"A". The equipment shall be strictly in accordance with the requirements of technical specification.
- ii. One set of documents incorporating the following particulars shall be included in the online offer- GTP, BOM, Drawings, Technical literature/ Manual for the offered equipment.
- iii. The bidder or his manufacturer should have <u>well established</u>, <u>prompt after sales service-support facility/network in India</u>. Necessary documentary evidence should be submitted along with the bid.
- iv. The price variation (PV) clause is not applicable for this SRM E-Enquiry.
