Sealed & super scribed quotations are hereby invited by undersigned for the work of AMC of AC including providing & fixing, repairing of 2T AC for 400 kV R.S. Division, Lonikand-II. Submit the sealed quotations to this office between **07.06.2024 from 11:00 Hrs to 13.06.2024 upto 18:00 Hrs** by considering following Terms & Conditions.

Terms & Conditions

- 1. Quotation should be duly filled in all respect & sealed envelope to be submitted to this office, within due date.
- 2. Rate shall be quoted, exclusive of taxes, in Schedule-A. The rate quoted shall be valid for 180 days from the date of opening the quotations. The amount of contract is limited to **Rs. 5,32,092/-.**
- 3. GST will be paid extra, as applicable.
- 4. Enclose duly attested & signed copies of following valid documents, along with quotations.
 - a. Valid registration under shop & establishment act or NOC of Grampanchayat for shop. The NOC of Gram panchayat should be valid & recent one.
 - b. Valid registration under GST.
 - c. Pan card xerox.
 - d. Experience certificate & satisfactory work completion certificate is mandatory from not below the rank of Executive Engineer within last five years.
 - e. Proof of Income tax return fill up of last 3 Assessment year.
 - f. Annexure B.
- 5. The envelope containing quotation should be properly sealed & subscribe Quotation for AMC of AC including providing & fixing, repairing of 2T AC for 400 kV R.S. (O&M) Division, Lonikand-II.
- 6. Conditional bids are not acceptable.
- 7. Undersigned reserves the right to place work order either partly or fully or to reject any or all the quotations without assigning any reason whatsoever. In normal course, the interpretation of the undersigned on any matter or decision given by him on any disputable points will be final and binding on you.
- 8. **Security deposit:** Security deposit i.e. 10% of Order value is to be paid after the issue of LOI. Same will be refunded after satisfactory completion of work order and guarantee period. In case of failure to execute work order in full or part, security deposit will be forfeited.

- 9. **Agreement bond:** As per rule, you will have to entered into contract agreement with MSETCL on stamp paper costing Rs. 500/-, before starting the work. Cost of stamp paper is to be borne by you.
- 10. **Work Place:** The work is to be carried out as per program decided by Executive Engineer, 400kV R.S. Division, Lonikand II or his representative deputed for this job. The outages will be arranged by Substation In charge, if required.
- 11. **Validity:** -This order will be valid for 12 months from issue of work order or exhausted the work order amount whichever is earlier. The AMC work should be completed every month as per mentioned in Schedule A and the work will be carried out at the place shown by our Addl.EE (Maint.) or his representative.
- 12. **Penalty:** If the work is not completed within stipulated time, the penalty @ 1/2% of the total contract price per week or part thereof, of delay subject to maximum of 10% of the executed contract price or total contract price for the entire scope of work whichever is higher.
- 13. **Risk & cost:** In case of maximum delay, the contract may be terminated by the owner & balance work shall be completed by the owner at the risk & cost of the contractor & balance work carried out through other Agency & difference in cost will be recovered from contractor Bill & SD. If the balance amount remained to be recovered, the same shall be recovered from contractor from their other contracts in MSETCL.
- 14. **Spare Part:** If any spare part requires to be replaced then agency should submit the report along with A.C no. and reasons of replacement of spare part to this office before delivery or replacement of spare part.
- 15. **Payment:** You have to submit the R.A. bill /Tax Invoice in triplicate to this office every month by mentioning your Service Tax & PAN No. etc. The Payment will be made on monthly basis within reasonable period through online banking method only after receiving the necessary certificate from Engineer In charge regarding satisfactory completion of work. The following documents should attach along with the tax invoice
 - a. Tax Invoice should be dated and work carried out period should mention on tax invoice.
 - b. Delivery challan should be submitted at the time of delivery of material.
 - c. Warranty certificate of material.
 - d. Job completion /site visiting sheet duly signed with engineer in charge.
- 16. **Accident:** -You will have to observe all safety rules and regulations while executing the work. The Company (MSETCL) will not provide compensation for any type of accident to your labors while execution of work. The MSETCL will not be responsible for any type of accident of your labor.
- 17. **Taxes:** The Income Tax and service tax will be deducted from your bill as per prevailing rates.
- 18. **Guarantee/warranty:** The Contractor shall guarantee/warranty that the materials will be new and in accordance with the contract documents and will be free from defects in material and workmanship for a period of 12 months (i.e. 1 { One } year) from the date of final acceptance of the entire scope of work by the Owner.
- 19. The control room shall not be utilized for residential purpose. You will have to arrange the residential accommodation of your labors, outside the compound of Sub-Station at your own cost.
- 20. You will have to make your own arrangement for transportation of machinery and T & P required for the said job including labors.
- 21. All required T&P, minor Misc. material required will be at your cost. The Company will not be responsible for any damage / theft to your T&P, Machinery etc. during execution of work / contract period.
- 22. The contract or any part thereof shall not be assigned/transferred or sublet without prior written permission of the undersigned.
- 23. The insurance of your labors will have to be arranged at your cost. If failed to do so any compensation or claim arise will be at your responsibility.

- 24. You shall abide with all Govt. Rules, Regulations and status for this work including Workman Compensation Act. Any deviation will be at your cost and risk.
- 25. In case of suspension of work or delay in work due to any reason or stay order of the Court of law, no compensation will be paid by the Company for idle labors / idle machinery etc. during the period.
- 26. All disputes / differences arising under /out of or in connection with this contract shall be subject to the exclusive jurisdiction of Pune court only.
