Experience of having successfully completed similar works amounting to 80% of estimated cost in single order or 50% of estimated cost in two order or 40% of estimated cost in three orders. **Experience certificates for successful completion of work along with work order** are required to submit for qualification of the bidder. The bidder should submit the experience only of State Govt. / Central Govt. / Semi Govt. / or Reputed Transmission Licensee. Experience certificates shall be signed by the officer **not below the rank of Executive Engineer**.
