**ANNEXURE (S)**  
**GENERAL TERMS AND CONDITIONS**

- 1) **GST:-**GST registration number must be quoted on the bill; otherwise purchase tax will be levied.
- 2) **DELIVERY:** - The time being essence of the contract, the supplier should strictly adhere to the delivery period as per schedule 'A'.
- 3) **PENALTY FOR LATE DELIVERY:** - In case the materials are not delivered in time, the supplier shall be liable to pay penalty @ ½ % of the price per week delayed, or part thereof, subject to a maximum of 10% reckoned on the contract value of such complete portion or section of the plant, equipment or material including the portion supplied which could not be brought in to commission due to any part thereof not being delivered in time. The penalty will be levied subject to **force majors'** conditions, for which documentary evidence will have to be produced to the satisfaction of the competent authority of the Board. In the event of failure to supply, our Company may purchase the ordered materials at the cost & risk of the supplier in the open market.
- 4) **SPECIFICATIONS:-**The materials offered should strictly conform to the specifications.
- 5) **PAYMENT OF BILLS:** - The bill should be submitted in triplicate to Ex. Engineer PAC Division, Karad. 100% payment will be released after 10 no. of Line Interface Unit (LIU) as per Schedule 'A', & after duly recorded the bill by the concerned authority. The payment will be release corresponding entry in SAP system & availability of fund at EHV O&M Circle, Karad.
- 7) **Warranty:** - The material offered should carry company's warranty against any deficiency in material or workmanship.
- 8) **CONSIGNEE:** -The Executive Engineer, PAC Division, Karad.
- 9) You will be deemed to be fully aware of the Company's General conditions of contract for the supply of equipment/material, terms of payment, penalty for later delivery etc. And any ignorance of these conditions will not exempt you from your liability to abide by the same.
