

## AMENDMENT-I

Sub.: Amendment to the re-tender (2<sup>nd</sup> call) for the work of Supply, installation and commissioning of rooftop solar PV projects at various 400kV substations under EHV PC O&M Zone, Pune.

This office has floated SRM re-tender (2<sup>nd</sup> call) for the work of Supply, installation and commissioning of rooftop solar PV projects at various 400kV substations under EHV PC O&M Zone, Pune, **amounting to Rs. 3,32,50,881/- (Including all taxes)** vide tender no. under reference. Now, amendment to the Price Variation Clause no. 4.5 of IFB & Clause at Sr. No. 9 of Annexure-A (GTC) in the Tender Documents of re-tender/Rfx under reference is issued as follows:

## A) Price Variation:

- 1. Ceiling/capping of + 20% on Price Variation for supply of material and equipment's of substation and no ceiling /capping on supply of materials of Transmission line. There shall be no ceiling / capping on Negative Price Variation.
- 2. Price Variation clause shall be applicable for the following Supply components only:
  - (a) <u>Substation</u>: Supply of Power Transformer/ITCs/Reactor, Circuit breakers, Instrument Transformers, Isolators, Relay panels, Gantry and equipment support structure with N&B, Control and Power Cables, PLCC/FOTE (Panel & Equipments).
  - (b) <u>Transmission Line</u>: Supply of Towers with N&B and Conductors. Note:
    - (1) For all other supply items the rates shall be on the FIRM price basis.
    - (2) For Civil and ETC works the rates shall be on the FIRM price basis.
- 3. The Price Variation shall be calculated from date of placement of order (LOA) or 4 months after published date of opening (including extension, if any) of Techno-Commercial bid of tender whichever is earlier.
- 4. The Price Variation shall be calculated as per IEEMA PV Formula and monthly indices published by IEEMA.

- 5. The Price Variation should be made applicable only if work in all respects is completed by agency within the contractual period or within extended time period approved by the Competent Authority.
- B) Other terms and conditions will remain unchanged.
- C) The due date for submission of said e-tender/Rfx is further extended up to Dtd. 24.07.2024 till 11:00 Hrs.

Probable Technical Bid Opening Date: Dtd. 24.07.2024 after 11:05 Hrs. (If possible). Probable Price Bid Opening Date: Dtd. 26.07.2024 after 11:00 Hrs. (If possible).
