- 7) The undersigned reserves the right to place order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever.
- 8) Please quote your PAN & GST No. on the quotation
- 9) Payment of bill will be made as per actual execution of work and as per the direction of Engineer in charge & as per availability of funds.
- 10) In case of any dispute the decision of the undersigned will be final and binding on the contractor.
