- 1. **NAME OF THE WORK:-**Work of online measurement of dew point & impurity in SF6 gas of 400 kV CBs under 400 KV RS Karad.
- 2. **DUE DATE:-** The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either personally or by post on or before **Dtd.01.08.2024upto 18:00 Hrs** positively.
- 3. **DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :-** Please submit the following documents along with offer :


