Online bids are invited in two bid system for SRM E-enquiry in r/o the work of survey by GPR (Ground Penetrating Radar) technique alongwith DGPS (for GPS coordinates) for locating underground cables of 220kV Hinjawadi-2- Hinjawadi-3 lines under EHV O&M Division, Pimpri Chinchwad, Pune **on or before 31.07.2024,18:30Hrs** on following terms and conditions:-

TERMS AND CONDITIONS

Submission of bid

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <https://srmetender.mahatransco.in/>

A. Techno –Commercial bid:

This should contain following valid documents certificates as a proof of qualifying pre-requisites, brochures, etc.

1. Scanned copy of EMD & tender fee receipt. In case of EMD exemption shall submit an undertaking duly notarized stating that enterprise shall supply all the materials of intended work contract, manufactured from its own unit. Also the registration of Micro & small enterprises should be valid on the date of submission of bid & the validity of same should be verified by certified chartered accountant in practice.
2. Valid copy of PAN card.
3. Valid copy of GSTIN registration
4. I.T return for the year FY 2022-23, FY 2023-24.
5. Valid shop act & establishment registration or NOC of Grampanchayat or Udyog Aadhaar certificate.
6. Valid Electrical contractor(registration) License

All general / technical/ commercial terms & conditions of the contract of the company are applicable to this contract.

B. Commercial bid:-

Bidder should upload the digitally signed price bid under commercial bid online.

1. Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tender fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
2. This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
3. The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.
4. **AGREEMENT** :- Bidder will have to execute the agreement bond with Executive Engineer, EHV O & M Division Pimpri Chinchwad, Pune on stamp paper of 500/-. The cost of stamp paper will be borne by you. After submission of agreement, the contractor will be called for scheduling the date of signing & execution of agreement in the office of Executive Engineer, EHV O & M Division Pimpri Chinchwad, Pune Until the agreement is executed, the MSETCL will not be liable to pay, nor shall the bidder be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the bidder.
5. **SECURITY DEPOSITE:** - Bidder will have to pay **Security Deposit of 10% of the work order value** within 7 days from the date of issue of work order in the form of FDR/D.D. of any Nationalized/ scheduled Bank in the favour of “MSETCL” at the office of The Executive Engineer, EHV O&M Dn Pimpri Chinchwad Pune, valid for one year or online payment NEFT/RTGS. If you fail to do so, the SD will be recovered from your first bill with interest i.e. 18% applicable. The Security deposit will be refunded only after satisfactory completion of the said work & NOC from Additional Executive Engineer, Line Maintenance Subdivision, Pimpri Chinchwad. Also, you will have to apply for refund of SD within 6 months after completion of work. If you fail to apply within stipulated period, the action as per CO’s rules will be taken.
6. **WORK EXECUTION SCHEDULE:** The work should be carried out immediately as per instruction of Executive Engineer or Engineer Incharge. The detailed scope of work included the work of survey by GPR (Ground Penetrating Radar) technique alongwith DGPS (for GPS coordinates) for locating underground cables of 220kV Hinjawadi-2- Hinjawadi-3 lines under EHV O&M Division, Pimpri Chinchwad, Pune. The detailed scope of work is strictly adhere to schedule A. After completion of survey the bidder

should submit DGPS & GPR survey report to AEE, Line Maintenance Sub-division, Pimpri Chinchwad.

7. **WORK COMPLETION PERIOD** :- The work should be executed as per work execution schedule within two(02) months from date of handing over of site.
8. **MODIFICATION & RECTIFICATION TO SURVEY WORK**: The work should be carried out as per satisfaction of Executive Engineer or Engineer Incharge & as per schedule ' A' If any rectification is suggested by Engineer-In-Charge, within settlement of final bill the bidder should carry out the same and submit all related deliverable to this office. No extra charges will be given for any modification or rectification. Correction should be done on his own cost
9. **VALIDITY**: Validity of the order is upto one year from the date of issue of order.
10. **PENALTY**:
 - a. **Performance of work**: If it is found that performance of work is unsatisfactory, or not as per norms of MSETCL, the contract is liable for termination at any stage of work without giving any prior notice and at contractor's entire risk & cost. The security deposit paid by the contractor shall be forfeited in that case.
 - b. **Delay in execution of work**: In case of delay in execution of work beyond work completion period, penalty @ ½ % per delayed week, maximum to 10% of order amount shall be levied on contract value.If the work is not carried out in the stipulated period, the works will be got done departmentally or through any other agency at your risk and cost even at higher rates, in addition to the penalty that shall be chargeable as mentioned above.
 - c. **Penalty for partly completion of work**: In case the contractor fail to complete the work entrusted, partly or fully, the balance work will be carried out through other agency and difference in cost will be recovered from contractor's bill and S.D. & the over & above balance shall be recovered from contractor or else penalty will be charged, **maximum** up to 10 % of order value whichever is higher.
 - d. To impose penalty in above (a), (b) & (c) case, for execution of work is discretion of AEE, Line Maintenance Sub-division, Pimpri Chinchwad under EHV O&M Division, Pimpri Chinchwad
11. **SUBMISSION OF BILLS/PAYMENT OF BILLS**: The tax invoice/if applicable E-Invoice along with MOM jointly certified by AEE, Line Maintenance Sub-division, Pimpri Chinchwad & the authorized supervisor of the agency should be submitted in triplicate to AEE, Line Maintenance Sub-division, Pimpri Chinchwad. You will have to provide Bank Details along with bill for RTGS/ NEFT Payment. Advance Revenue stamp receipt to be provided along with Bill. Please quote PAN No. on your bill. The service entry of the bills will be carried out by AEE, Line Maintenance Sub-division, Pimpri Chinchwad in SAP. Scrutinizing & auditing will be done at Division Office and payment will be effected accordingly subject to availability of funds.
12. **TAXES**: Income Tax & all other applicable taxes will be deducted as per prevailing rates from your bill, as per rule, if applicable. GST Number should be mentioned on bidder invoice.

13. **HINDRANCE OF WORK:-** If the work has to be suspended due to any reason, shut down etc., the MSETCL shall not pay any compensation/ damage to the contractor towards items like labor, idle machinery, vehicle etc. however in such cases the contractor will be paid for the actual work executed by him under the supervision & measured by concerned engineer
14. In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.
15. **TERMINATION OF CONTRACT:-** The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 3 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor. Undue delay in completion of contract work is also liable to getting the work done through other agencies at the risk and cost of the contractor.
16. **Jurisdiction:** All dispute or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE court only.
17. **GENERAL:** You should make yourself fully aware of M.S.E.T.Co.Ltd.'s general condition of contract for supply of material and execution of work.
