Sealed and super scribed quotations are invited for hiring of LMV(Diesel) such as Tata Sumo/Bolero/ Utility vehicle equivalent or above for Maintenance /Testing unit under 400kV R.S. Division Talandge for F.Y.2024-25 & 2025-26, as detailed in Schedule 'A' enclosed herewith subject to the following terms and conditions :-

- 1) The contract period is for one year.
- 2) The vehicle model should be between last 05 years from **July-2024**.
- 3) The rate should be quoted as per schedule 'A'
- 4) 100% payment will be effected in reasonable time on submission of monthly R.A. bills.
- 5) You will have to pay security deposit of 5% of the total amount of the order within 7 days from the date of receipt of firm order, if asked for.
- 6) The quotations not confirming to the specifications are likely to be rejected.
- 7) You have to submit agreement on stamp paper of Rs.500/-.The cost of stamp paper to be borne by you.
- 8) The average consumption of the vehicle given on hire basis should be **12Km/ litre**, irrespective of actual average of the vehicle. If the average consumption is less than above, the proportionate amount will be deducted from your bills on the calculation of the km run.
- 9) All the maintenance charges of the vehicle, driver salary, overtime allowance and other benefits of the driver will have to be borne by you.
- 10) **All valid RTO related documents such as Tourist Permit, RC, TC book, fitness certificate, insurance, PAN card copy, GST Registration certificate (if applicable) etc. should be submitted along with the quotation.**
- 11) Only **Diesel** will be supplied by MSETCL. The engine oil and lubricants, repair of vehicle, driver salary will be arranged by you at your cost.
- 12) Per day duty will be of 10 hours. Overtime will be applicable after 10 hours of duty.

- 13) The driver of vehicle must have valid license from RTO authorities, further he must be polite, obedient, punctual and without illicit habits.
- 14) The vehicle should be parked in **MSETCL office premises on all working days**, alternately if you insist that the vehicle should park at your place then after the completion of company's duty you may arrange to park the vehicle after taking kilometer reading at the time of leaving the company's parking place and bringing of vehicle for company's duty respectively.
- 15) The vehicle should be made available at any time on any day.
- 16) The quotation should reach this office on or **before 02.08.2024 up to 18:00 hrs.**

- 17) Your scan copy of PAN should be enclosed with quotation.
- 18) The right to reject any or all the quotations is reserved by the undersigned.
- 19) The quotation should be properly sealed and superscribed on the envelope As
