With reference to above subject, you are requested to quote lowest possible rates for servicing, overhauling of Valve cooling motors & its alignment with pumps and Servicing, overhauling and testing of LVAC Breakers 2000C and 3200 D along with the spares for Pole-1& 2 during Annual Outage 2024 at HVDC Padghe as per specification in Schedule – A with following terms and conditions.

TERMS AND CONDITIONS:

1. The EMD and Tender fees is to be paid online on the account of '*The Company*' through website <https://srmeter.tender.mahatransco.in>. **Due Date- 14.08.2024 upto 10:00 hrs.**
2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- The bidder should **submit at least one similar nature of work order copy equal to minimum 50% or more than RFx amount. The order should be after 01st April 2019 along with its experience certificate for similar nature of work as per schedule-A.**
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer.

Commercial Bid.

- PAN Card of the firm/proprietor as the case may be. Income Tax return for last one year.
- Certificate of Registration for GST with latest paid Challan.
- Valid Govt. Electrical contractor license issued by the Government of Maharashtra.
- Shop Act License.

- Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- Net Worth of last one year duly certified by Chartered Accountant should not be less than 25% of estimated cost.

3. **Scope of Work:**

- Servicing, overhauling of Valve cooling motors & its alignment with pumps and Servicing, overhauling and testing of LVAC Breakers 2000C and 3200 D along with the spares for Pole-1& 2 during Annual Outage 2024 at HVDC Padghe.
 - '**The Company**' will hand over all the Breakers in normal working/Healthy condition and it will be the sole Responsibility of vendor to hand over all the Breakers in healthy condition after maintenance and testing. Any component failure during the process of maintenance is to be supplied by the vendor free of cost.
 - Work completion certificate is to be submitted by the Vendor after testing and maintenance of Breakers.
 - Also vendor should give warranty of six months from the date of Maintenance.
 - For execution of work, all T&Ps should be brought by agency personnel during work such as CRC, Polish paper, blower, Jelly, Timing Kit etc & extra material and T&P will not be given by '**The Company**'.
 - 'The company' will hand over all the motors and pumps to the vendor in normal working/healthy condition and it will be the sole responsibility of the vendor to hand over all the motors and pumps in Healthy/Working condition after maintenance and Testing. Any component failure during the process of maintenance and alignment is to be replaced by the vendor free of cost.
 - Work completion certificate needs to be submitted with the bill.
 - Vendor must give warranty for 6 months from the date of Maintenance and Alignment.
 - Vendor must bring all T&P including Polish paper .CRC, Jelly etc. required for maintenance and alignment of valve cooling pumps and motors. No material will be provided by 'The Company'.
 - Precision of Alignment should be (Toleration:<5tau)
4. The Contractor rates should be in percentage (%) based on estimate cost.
 5. Rates should be valid for 120 days after commercial opening of the enquiry.
 6. Rfx fee is Rs.118/- including taxes (Is non refundable).
 7. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
 8. Income Tax will be deducted from contractor's bill, as per Govt. Rules
 9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
 10. Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company in the approved proforma on stamp paper of Rs. 500/- (Five Hundred Only) at your cost as per the D.O. Itr no. Mudrank-2009/2707/Pra.Kra./326/M-1 dtd 09.10.09. and Co.'s Adm. Circular no. 207 dtd 17.04.10.. Until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, for the work executed under the contract.

You have to pay the security deposit of amount equal to 10%(Ten) of the order value within 07 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (O&M) Circle, Padghe, Tal. Bhiwandi, Dist. Thane, Demand Draft or equivalent Govt. Securities or Fixed Deposit Receipt or RTGS.
