- Submit the performance /experience certificate for similar nature of works as per “Schedule-A” at any HVDC substation.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex.- Engineer or equivalent. The bidder shall also submit the copy of the work order mentioned in the experience certificate as testimonials.

Commercial Bid.

- PAN Card of the firm/proprietor as the case may be. Income Tax return for last three year.
 - Certificate of Registration for GST with latest paid Challan.
 - P.F. Registration.
 - Valid Electrical Contractor License and Shop Act License issued by Government of Maharashtra.
 - List of skilled personnel’s along with qualifications.
 - For execution of work, all T&Ps should be bring by agency personnel during annual outage such as CRC, Polish paper, blower, Jelly etc & extra material and T&P will not be given by MSETCL.
 - Annual Turnover for last 3 years duly certified by Chartered Accountant should not less than 60% of the estimated cost with UDIN Number.
 - Net Worth of last 3 years duly certified by Chartered Accountant should not be less than 25% of estimated cost with UDIN Number.
- 3) The Contractor rates should be in percentage (%) based on estimate cost.
 - 4) RFx fee is Rs.118/- including GST (Is nonrefundable)
 - 5) If the above documents are not applicable then submit Eligible/ Non eligible documents list.
 - 6) Rates should be valid for 120 days from the date of commercial opening of RFx.

7) Rates should be inclusive of all taxes should be Mentioned Separately.

8) You have to pay the security deposit of amount equal to 10%(Ten) of the order value within 07 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (O&M) Circle, Padghe, Tal. Bhiwandi, Dist. Thane, Demand Draft or equivalent Govt. Securities or Fixed Deposit Receipt or RTGS.

12) Rates should be valid for 120 days from the date of commercial opening of RFx.

13) Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

14) Agency should be rate quoted at Estimate cost on Percentage (%) basis.

15) Agreement Clause: - The contractor shall have to enter into an agreement with the company in the approved proforma on stamp paper of Rs. 500/-.
