Sealed quotations are invited from experienced contractors for the above said work as per enclosed schedule "A" on or before 19.08.2024 up to 16:00 Hrs. The detailed scope of works is given below.

- 1. DUE DATE: The quotation shall be sent in sealed cover, clearly superscribed with the words "Quotation due on dt. 19.08.2024 for grass cutting and branching of trees in the surrounding area of 400 KV & 220 KV switchyard of 400 KV RS Kalwa and should reach this office on or before due dated i.e. 19.08.2024 up to 16:00 Hrs.
- 2. QUOTED RATES: : The quoted rates should include the cost of all skilled & Unskilled labor, and also the requisite consumables, T&P and all incidental charges such as traveling/ Transportation, accommodation etc. The quotations not confirming to the specifications are likely to be rejected.
- VALIDITY OF OFFER: The offer should be valid for our acceptance for a period of 90 days from the due date of opening.
- 4. The vendor will have to pay security deposit @ 10% of work order amount in the form of BG./FDR in the name of MSETCL Superintending Engineer, EHV O&M Circle Kalwa within 7 days from receipt of the order and after completion of guarantee period S.D. will be refunded.
- RATES: Rates should be quoted as per format mentioned in schedule 'A' only. Rates should be quoted both in words and figures, overwriting /surcharges should be attested.

- 6. During the execution of work if any damages occur to the MSETCL's property the same have to be made good at your cost. In that case, the decision of the undersign will be final and binding on the contractor.
- 7. Payment will be made within reasonable time after completion of work and submission of bill (in triplicate), advance stamp receipt along with satisfactory certificate from the Concern Engineer In charge and the payment will be done at EHV (O&M) Circle Kalwa. Mention HSN/SAC Code on bill and mention the PAN No for Income Tax purpose also bidder should submit the last paid GST challan (GSTR1 and GSTR3B) along with the bill.
- SCOPE OF WORK: Scope of the work is as per schedule A and as per directives of concerned S/s Incharge..
- 9. The bidder should submit the good quality of material. Material supplied must be inspected by concerned Executive Engineer or his representative before Delivery, if the material found not good than order may be cancelled or will be given to the 2<sup>nd</sup> lowest vendor.
  The undersigned reserves the right to reject any or all quotations without assigning any reasons.
- 10. Document required to be submitted along with offer:-
  - A] GST registration Certificate,
  - B] Copy of registration under Shop Establishment Act.
  - C] PAN Card Copy
  - D] Similar Work Experience.

Notwithstanding anything stated herein, the Board's general condition of contract shall be applicable to the contract, as far as they are applicable.
