You are requested to submit your offer in sealed quotation for the work of providing & fixing of Split type Air Conditioners required at newly constructed control room at 400kV R.S. Division, Lonikand-II as per enclosed '**Schedule A**' so as to reach this office on or before **dtd-23.08.2024 at 18:00 Hrs** considering given terms & conditions. 1. Envelope containing associated documents- This contain document as mentioned below.
  - a) PAN Card
  - b) Submit GST registration certificate
  - c) Valid registration under shop & establishment act or NOC of Grampanchayat for shop. The NOC of Grampanchayat should be valid & recent one.
  - d) The bidder should submit Make (Brand name) & the detailed guaranteed features of specifications along with illustrated printed catalogue of the offered.
  - e) Experience certificate of Providing & Fixing of Split Type Air Conditioner during last 05 years in MSETCL/Govt organization/PSU Bank issued by an authority not below the rank of Executive Engineer or equivalent.
  - f) I.T. Return submitted for the last 3 consecutive financial years i.e. 2020-21,2021-22 & 2022-23.

2. Envelope containing price bid documents- This should contain only price bid.

The prescribed form i.e. form for quoting % rate for item included in Schedule A duly filled in with the % rates (above/below) written in words & figures duly signed should be submitted.

Please clearly mention on envelope as for associated documents & for price bid document along with bidder/agency name.

Both these envelopes should be enclosed in big size envelope which is sealed & super scribed.

- After verifying the full documents in envelope-1, if bidder fulfills the desired pre-requisites, envelope-2 will be opened. If not then envelope 2 will not be opened & same is rejected/disqualified.
- Quotations with incomplete details or submitted without sealing or super scribed or not submitted in prescribed form etc are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible in delay in postal transit.
- The documents of an offer shall be written legibly & free from erasures, overwriting or conversion of figures correction where unavoidable shall be made by crossing out, rewriting, initialing & dating.
- The right to reject all or any of the quotation without assigning any reason, whatsoever for the rejection of any quotation or all the quotations or to place an order for full quantity or part thereof or to finalize the order on time preferred basis or to split the order quantity wise is reserved with the undersigned.
- Bidder should not submit the conditional quotation, such offer shall liable for rejection.

#### **TERMS & CONDITIONS:**

1. **Name of work:** - work of providing & fixing of Split type Air Conditioners required at newly constructed control room at 400kV R.S. Division, Lonikand-II
2. **Scope of work:** - The scope of work is as detailed in Schedule A. The work should be carried out as per instructions of Engineer Incharge or his representative.
3. **Estimated amount:** - **Rs. 3,97,082/-** (including GST & all taxes) & Rs. 4,08,994/- (including 3% Contingencies, GST & all taxes.)
4. **Security deposit:** -
  - A. Successful bidder will have to pay security deposit of 10% of the proposed value of work order or SD applicable as per rules of MSETCL to this office within 14 days from the date of receipt of this order in the form of D.D/FDR/Bank Guarantee of nationalized or Scheduled Bank or may pay through online transaction to account No. 20077001846, IFSC Code MAHB0000717 of Bank of Maharashtra. If you fail to do so, the security deposit will be recovered with interest @ 18% p.a. or as prevailing rate.
  - B. The refund of S.D. application should submit within 6 months after completion of contract. If you fail to apply within stipulated period, the action as per MSETCL Co.'s rules will be taken.
5. **Agreement:** -Contractor shall have to enter in to agreement on bond paper of Rs. 500/-as per rule. The cost of the bond paper will be borne by contractor.
6. **Validity of Work Order:** - The validity of work order is 12 Months or exhaustion of work order amount, whichever is earlier.
7. **Work completion period:** - Work of providing & fixing of Split Type Air Conditioners required at newly constructed control room at 400 kV R. S. Division, Lonikand –II shall be completed within 3 months from date of LOI.
8. All General /Technical / Commercial terms and conditions of the contract of the MSETCL Company are applicable to this contract.

9. **Payment:** - You have to submit the Tax Invoice in triplicate to this office. Payment will be made after completion of work. R.A. Bill will also be acceptable for part work as per actual measurement basis & as per availability of funds after submitting the bill & necessary certificate submitted by Engineer- In charge of 400KV Lonikand-II. (GST no. should be mention on bill)
10. **GUARANTEE PERIOD:** - The Contractor shall have to furnish warrantee for 1 year on product and 5 years on Compressor manufacturer warranty from the date of installation against any manufacturing defect etc. The undertaking as such should be send along with invoice. Any manufacturing defect observed in the material within this period, will have to be replaced free of cost by Contractor.
11. **Penalty:** - If you fail to carry out the work in stipulated time as mentioned above, you will be liable to pay penalty of 1/2% of the total work order value per week or part thereof, of delay subject to maximum of 10% of the executed work order value or total work order value for the entire scope of work whichever is higher.
12. The material mentioned in the Schedule shall be as per specification and having ISI mark & of standard brand like Voltas, Blue Star Ltd, Carrier etc. If any dispute arises regarding the technical specifications required as per actual site condition, the decision of the Executive Engineer, 400kV R. S. Division, Lonikand-II will be final.
13. Any type of damage occurred during the execution of work due to bad workmanship the contractor has to make it good and the cost of the same will be on contractor's account.
14. **Workmen's Compensation Under Act – 1923 (VII of 1923):** You will be responsible for & will pay any compensation to your workmen under Workmen's Compensation Act 1923 for injuries caused to your workmen.
22. You will have to arrange for insurance at your cost for the men, material vehicle etc. associated with the contract till the work are satisfactory completed. The company will not be responsible for any accident or loss, damage, theft, mishap. You will have to lodge, pursue & settle any or all such claims through Insurance Co. without involving MSETCL in the process.
23. **Consignee:** - The Additional Executive Engineer (Maintenance), 400kV R.S. Division, Lonikand-II or his representative is the consignee material & do the verification of material.
24. **Packing, Forwarding & Transportation etc:** The Contractor shall be fully responsible for packing, forwarding, transportation by railways or any other authorized mode of transport, clearance of equipment and further transportation at site to place of works/storage yards etc, in respect of material in his scope/possession.
25. The Contractor wherever applicable shall, after proper painting, pack and crate all equipment in such a manner as to protect them from deterioration and damage during rail/road or any other authorized mode of transport. The Contractor shall be held responsible for all damages/losses due to improper packing.
26. The contractor shall also be fully responsible for safe transportation of owner supplied material to be issued from his stores by owner for the works against contract.
14. If any accident occurs to any of your worker/your supervisor/or outsiders during work execution will be on your account. The Company will not be responsible for such accident/ compensation payment etc.
15. **Taxes:** - Income tax & other necessary taxes will be deducted at source from your bill.

16. In case of any negligence in work observed, the amount equivalent, to the loss will be recovered from Contractor's bill and if the negligence is repeated the contract will be cancelled and the Security Deposit paid by the contractor will be forfeited.
17. If it is found that performance of work is unsatisfactory, the contract is liable for termination without giving any prior notice and at your entire risk. The security deposit paid by you shall be forfeited. You shall not entrust the work on sub-contract /transfer or assign the contract or any part thereof to any third party. In case any deviations observed it will be treated as breach of contract and the contract will be terminated at your entire risk and cost.
18. In case of the difference of opinion about the interpretation of terms and conditions between you & M.S.E.T.C.L. the decision of the undersigned will be final & binding upon you.
19. This office reserves all the rights to reject any or all quotation without assigning any reasons thereof.
20. For legal disputes, if any, jurisdiction shall be exclusively of Pune courts.
