- 1) The rate should be inclusive of driver salary, fuel cost and municipal/ cantonment board area toll taxes.
- 2) The monthly limit of Km run will be 2000 Km. Duty timing will be 9:30 to 19:30 hrs. subjected to change.
- 3) Preference shall be given to such vehicle which are registered on or later Apr 2018 (Submit documentary proof).
- 4) Your sealed quotations should reach this office on or before **dt. 30.08.2024 at 12:00 Hrs. without fail. Date of opening of quotations is 02.09.2024 at 15.00 Hrs. (Probable) Quotations received after due date & time will not be considered.**
- 5) Following document shall be submitted along with sealed quotations: -
 - a) Valid copy of R/C Book
 - b) Valid copy of Vehicle Insurance
 - c) Valid copy of certificate of fitness/passing certificate
 - d) Valid copy of valid tourist permit
 - e) Valid copy of Certificate of Taxation/Road Tax
 - f) Valid copy of PUC
 - g) Copy of PAN card
 - h) Valid Copy of Shop Act/NOC from Grampanchayat
 - i) Driving license, driver batch details
 - j) Professional Tax
 - k) GST registration Certificate if applicable/undertaking.
