3.0 QUALIFYING REQUIREMENT

Compulsory Primary Documents:

- i) Valid Certificate of Registration of appropriate class from PWD/MES/Railways/Jeevan Pradhikaran. etc. OR from Any Govt./Semi Govt. & Central Government. Undertaking regarding exemption availed by the agency having registration value more than 1.5 crores in case of PWD.
