- 5) Agreement: An agreement is required to be executed by bidder with the company on stamp paper of Rs. 500/- containing all above terms & conditions of the order before its execution. The cost of the stamp paper should be borne by you.
- Security Deposit: -The contractor have to pay the security deposit of 10 % of the estimated amount OR of the quoted amount whichever is higher, at 400kV RS O&M Dn Chakan, Pune within 07 days from issuing of LOI. The security deposit can be paid by Cash/ NEFT/RTGS/Online payment/DD/BG/FDR in favor of Executive Engineer, 400kV RS O&M Dn Chakan. In case of DD/BG/FDR, the validity shall be up to 90 days from the due date of completion of work.
- The security deposit will be refunded within 90 days from the date of completion of work and by obtaining NOC from AEE Maint and testing Pune and if applied within 03 months after the work completion date.

- 9) There should not be any damage to the kit during execution of calibration work. Any damages to the equipment shall be made good by the contractor except normal wear and tear.

- A) Delay in execution of work: If the contractor fails to complete the work in all respect in stipulated time as mentioned above, he will be liable to pay penalty at rate of ½ % per day subject to maximum limit of 10% of the total value of the order.
- B) Performance of work: During the contract period, if it is found that performance of work is

satisfactory, the contract is liable for termination by giving 3 days prior notice and at contractor's entire risk and the security deposit paid by contractor shall be forfeited.

- C) Delay in starting the work: If it is found that the contractor fails to execute the agreement / Pay the Security Deposit / start the work within stipulated time period, the contract is liable for termination by giving 3 days prior notice and at contractor's entire risk and the EMD paid shall be forfeited.
- D) GUARANTEE PERIOD: The Guarantee/warranty period for the material and works shall be 1 year from the satisfactory completion of a particular work. The Warranty/Guarantee certificate shall also be submitted by the Manufacturer / contractor for the completed works. Any defects developed during guarantee period should be rectified at the cost of contractor.
- 11) OPERATING OFFICER: The concern testing /Maint AdEE will be operating officer.
- 12) PAYMENT TERMS: 100% payment will be done after the work completion and on the submission of Tax Invoice.
- 13) MODE OF PAYEMNT: The payment will be disbursed vide RTGS / NEFT by Division office.
- 14) DEDUCTION OF TAXES: Statutory taxes as per rule may be deducted from the contractor's bill, as applicable.
