Digitally signed online bids are invited through SRM E-Enquiry process of MSETCL in <u>two</u> <u>bid system</u> from bidders who are registered Vendors of MSETCL on or before dt. <u>15.10.2024</u>.

Terms and Conditions:

1) <u>Prequalification/Technical bid</u>: This bid will be opened prior to the price bid & should contain following technical qualifying documents of bidder.

Qualifying conditions:

- a) Proof of firm being registered as shop establishment/firm/Company as applicable.
- b) Valid GST registration certificate.
- c) Copy of PAN/TAN.
- d) Experience certificate of execution of similar type of work from authority not below the rank of Executive Engineer OR Equivalent in Govt./Semi Govt. Utility.

2) Price bid/Commercial bid:-

This bid will be opened in respect of technically qualified bidders only i.e. Bidders who are qualified in Technical bid or submitted technical qualifying documents successfully. This bid should contain the rate quoted by agency as per the schedule. The rates quoted shall inclusive of all the material, T&P, taxes & personal required for execution of the work.

- 3) SCOPE OF WORK: The scope of work consists of "Supply of petrol driven (chain saw) tree cutting machine for LMSDNs, under EHV O&M Division Ratnagiri " as indicated in schedule 'A' attached.
- 4) VALUE OF WORK: The overall contract value of the work entrusted to you, is limited upto Rs. 34,000/- (Rs. Thirty-Four Thousand only) including all taxes, duties and incidental charges.
- 5) RATES: Rates in Schedule 'A' are inclusive of GST. No extra amount against any taxes, transport will be given at any cost.
- 6) PENALTY: The material shall be supplied within 30 days from the date of receipt of work order otherwise you will be liable to pay penalty at rate @ ½% per week subject to max.10% of the total value of work order amount.

- 7) MATERIAL: It is mandatory to supply branded & quality material strictly confirming to our specifications & type as stated in schedule. If any defect observed in the material supplied by you, the same should be replaced by you free of cost & without delay.
- 8) PAYMENT: You will have to submit the first and final bill in the name of EHV O&M Division, Ratnagiri to concern S/DN In-charge, after satisfactory completion of work for the works executed. After receipt of technically scrutinized bill in triplicate (Indicating PAN No., GST Reg. No.) with Guarantee certificate to this office, 100% payment will be made in reasonable time subject to availability of funds. No advance/ part payment will be made.
- 9) CONSIGNEE: The ordered material as per schedule 'A' should be delivered to EHV O&M Division, Ratnagiri within 30 days from the date of dispatch of work order.
- 10) COMPENSATION: If any accident occurs to any of your worker/your Supervisor/or outsiders during execution of the work will be on your account. The MSETCL Company will not be responsible for such accident/compensation payment etc.
- 11)DISQUALIFICATION: Bid shall be disqualified for following case:
 - a) Disclosing untrue and/or false information or withholding information or part of information.
 - b) Record of poor performance such as unsatisfactory work or abandoning the work or delay in work etc.
 - c) Insufficient experience.
 - d) Non Payment of requisite EMD.
 - e) Non submission of document as per above list.
- 12)SAMPLE: The Sample of each item should be got approved from the undersigned, before delivery. Undersigned has the power to reject any item if not confirms to our specification, type & branded quality at any stage.
- 13)GUARANTEE for Quality of Material: Material supplied by you should be guaranteed for a period of 12 months from date of supply. If any defect is notified within Guarantee period, the same will have to be got rectified by you at your cost & risk within 15 days from date of intimation by concern officer. The guarantee certificate should be submitted with the bill. If defect not rectified by you, then security deposit will be forfeited without further notice.
- 14)Other standard terms and conditions of MSETCL for supply orders will be applicable in this case also.
- 15)TAXES: GST as applicable is included in the work order value. Taxeswill be recovered as per prevailing rates from your bill. You should mention PAN No. & GST No. on your bills.
- 16)DISPUTE: In case of any dispute, arising out of or in connection with this contract, shall be to thejurisdiction of Ratnagiri Court only.
- 17) CANCELLATION OF ORDER: MSETCL reserves the right to cancel the order fully or any portion thereof without assigning any reasons at any stage.
- 18) SECURITY DEPOSIT: Security deposit i.e. 10% of order value to be paid within 7 days in terms of cash/DD/Bank Guarantee of Nationalized bank/scheduled bank in favour of the Superintending Engineer, EHV O&M Circle Kolhapur from the date of issue of order. The same will be refunded in the normal course, after satisfactory completion of work subject to deductions, if any.
- 19)RISK & COST: If you fail to supply the materials in stipulated time the balance materials will be procured at your risk and cost or Security deposit will be forfeited in addition to above.
- 20) Bidders have to submit an undertaking in the attached Proforma 'ANNEXURE-G' declaring that their Firm is not Debarred/Blacklisted by Govt./Semi Govt./Other Power Utilities, anywhere.

21) The Technical bid will be opened online in respect of all SRM tender received. The commercial bid will be opened online in respect of those tenders & who are qualified in technical bid i.e. submitted all digitally signed documents/ certificate in technical bid as required in satisfactory manner.

22) Firm/ Bidder has to pay EMD irrespective of SRM system asks for the Same, EMD exemption is only for below mentioned conditions:

- 1) The Micro and small enterprise (Only manufacturing and service enterprise) as defined in MSMED Act, 2006 are exempted from paying EMD and tender fees. The Udyog Aadhar Memorandum and Udyog Aadhar Registration certificate submitted by said enterprises should indicate the same material / service as required against the tender floated.
- 2) The Bidder has to pay EMD and tender fees in following cases:
 - a) If the micro/small enterprise registration certificate does not indicate the relevant classification code covering material / service as required against the tender floated.
 - b) If investment in the plant and machinery or equipment exceeds the threshold limit indicated in the MSMED Act, 2006 (at present the threshold prescribed limit being for Micro-uptoRs. 25 Lakhs small Rs. 25 Lakhs to Rs. 5 Crs. as investment in plant and machinery and for micro –up to Rs.10 Lakhs: small Rs. 10 Lakhs to Rs. 2 Crs. as investment in equipment).
- 3) In case of works contract, if the Micro small enterprise submits that the enterprise shall supply all the materials of intended works contract, manufactured from its own unit, then it shall be eligible for exemption of payment of EMD & tender fees to MSETCL. However, an undertaking duly notarized from micro and small Enterprise to this effect is to be submitted along with bid.
- 4) The works contractor except as stated above and Traders are excluded from the benefits of EMD and Tender fees, hence shall be required to pay EMD or Tender fees while participating for e-tender process at MSETCL.
- 5) The registration certificate as submitted by micro & small enterprise should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountants in practice.
- 23) Undersigned reserve the right to cancel order in part or full at any time without giving the notice.
