If air conditioners are required to be repaired at your shop necessary transportation expenses

shall be paid by you.

The bill for charges should be given quarterly which shall be paid on certifying by the concerned Engineer-in-charge on submission of bill in triplicate.

The undersigned reserves the right to reject any or all quotations without assigning any 7.

Taxes, if any, should be mentioned extra, if not mentioned, it will be considered as inclusive 8. of all taxes & charges.

Income tax, Insurance, Labour cess, GST or any other taxes as applicable will be recovered

from the bill on the total value of the work done as per the prevailing rates.

No interest will be allowed on this deposit. If on breach of contract during contract period, S.D will be forfeited without assigning any reason. The amount will be refunded after expiry of warranty period subjected to deduction, if any forfeited as per the terms and condition.

12. Whenever there is paucity of funds, the priority of payments of bills of various agencies will be decided by the undersigned and all the rights in this regards are reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest /

compensation due to delay in their payments of bills on account of paucity of funds.

The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract in any respect or undue delay in execution of work/starting of the work. If the contract is terminated because of the vendor, the security deposit will be forfeited. The contractors shall employ and provide on-site only such employees who are skilled and experienced for execution and supervision of works. The contractor shall provide housing accommodation to his employees. The contractor should ensure that his staff uses the requisite safety equipment. The employees should be duly insured against any such eventuality.

14. The contractors shall be responsible for any injury / accident to his employees, payment of compensations; insurance etc. as may require to be paid eventually, shall be borne by the

contractor himself. The work should be carried out as per Board's work regulation.

15. All disputes, differences related to the tender/contract shall be subject to the exclusive jurisdiction of Thane District Court.

16. If the personal is found sleeping/ unsatisfactory work, absent, mis-behaviour or any other objectionable activity, penalty proportionate to monthly rate will be deducted from the bill.

17. Income tax or any other taxes as applicable will be recovered from your bills on the total value of the work done as per the prevailing rates.
