
TERMS & CONDITIONS:-

3. 100% payment will be made after receiving of bills in triplicate. Payment will be effected at Division level as per availability of funds.
4. You will have to pay the security deposit of 5% of the order value within 15 days from the date of receipt of firm order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work.
5. The quotations not confirming to the specifications are likely to be rejected.


