Please submit your reasonable offers for Hydraulic Conductor cutting machine, suitable for Live Line operations at Hot Line Unit Mudshingi under EHV O&M Circle, Kolhapur with following specifications as mentioned in scheduled A.

- 1. <u>Due Date</u>: the quotations complete in all respects, dully sealed and super scribed should be submitted to this office on or before 16.12.2024 **upto 17:00 hrs**.
- 1. You should have to submit the following documents along with sealed quotation
 - I) Proof of PAN Card
 - II) Proof of GST registration certificate
- 1. Specifications of Hydraulic Conductor cutting machine suitable for Live Line operations.
- * Light in weight- the machine should be lesser than 10 kg
- * The pump storage tank and other parts must form a complete metallic cage to avoid sparking with other metal parts.
- * The oil requirement should be lesser than 100 CC
- * Max pressure should be 700 bar and max output required is 11 tones/96N
- * Since it should be dedicated cutting tool, possibly it should be portable and without detachable pipes arrangement

preferable in-built type.

- * The cutting metal should preferably be M2 grade hardened steel with more than 60 RC
- * Cutting blades should be easily replaceable
- * Cutting head should be 180 Degree swivel and lock pin type
 - 1. Quoted rates: the taxes applicable if any should be quoted distinctly, otherwise rates should be considered as including all taxes.
 - 2. <u>Delivery period</u>: the Hydraulic Conductor cutting machine should be supplied within 30 days from date of issue of work order.
 - 3. <u>Penalty</u>: if the material is not supplied within stipulated time, penalty at the rate of ½ % per week, subject to 10% maximum order value will be recovered from your bill.
 - 4. Terms of payment: 100% payment will be effected to you, subject to availability of funds.
 - 5. <u>Payments</u>: the bills in duplicate should be submitted to this office for payment, with necessary documents as Manual, warranty card etc., HLU Mudshingi Incharge, EHV O&M Circle, Kolhapur will certify and record the bills and carryout necessary SAP activities against the supply of shoes.
 - 6. <u>Guarantee / warantee</u>: you have to furnish the guarantee / warranty of material as per manufacturing standards from the date of receipt of material against any manufacturing defect etc. The understanding as such should be sent along with the bill.
 - 7. Quality of materials: the quality of material should be as per specification in Schedule A.
 - 8. <u>Jurisdiction</u>: all disputes or difference arising out of this order for supply, if concluded shall subject to exclusive jurisdiction of Kolhapur court only.

- 9. <u>Security Deposit</u>: you have to pay security deposit of 10% of order value in form of cash / DD / BG which will be refunded after completion of warranty period.
- 10. Consignee: the ordered material should be delivered to Hot Line Unit, Mudshingi.
- 11. If you fail to supply the material in stipulated time, material will be procured at your risk and cost.
- 12. You are also deemed to be fully aware of Company's general conditions for supply of materials.
- 13. 100% payment will be made after receipt of material.
- 14. Remaining all conditions will be as per MSETCL rules and procedures.
