
CIRCULAR INVITING QUOTATIONS FOR WORKS:

2. The order amount will be limited upto Rs.10.00 Lakhs including all taxes.
3. The rates should be valid for 30 days from the date of receipt of the quotations.
4. 100% payment will be made against receiving of bills & as per availability of funds.
5. The bills in triplicate, advance stamp receipt should be submitted to concerned circle office. Service entry will be made at circle office.
6. You will have to pay the security deposit of 5% of the order value within Seven days from the date of receipt of firm order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work.
