A) TERMS AND CONDITIONS

Submission of bid:

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <https://srmetender.mahatransco.in>

A) Techno –Commercial bid:

I]	STATUTORY LICENSES / REGISTRATION:-
1	The bidder or his Joint Venture partner should have a valid Electrical Contractor's License issued by the Government of Maharashtra for work of erection/commissioning of EHV equipment
2	The bidder should be registered under GST Act
3	The bidder shall submit the copy of PAN card along with bid.
4	The bidder shall submit the Technical specification of Drone camera.
5	The bidder registered under S.S.I / N.S.I.C/ MSME certificate for the SRM portal shall also pay the EMD in the following cases, i) If S.S.I / N.S.I.C./ MSME certificate do not indicate Material / Service required against this Tender. ii) If Turnover or Manufacturing capacity exceeds the limit indicated in S.S.I / N.S.I.C./MSME certificate specified by the concerned authority to avail the benefit of E.M.D. exemption. If, required E.M.D. is not paid by the Bidder, the offer is liable for rejection.

1	Bidder or his Joint Venture partner should have experience of similar work (means work The of either Monkey patrolling or drone Patrolling of EHV Lines Single Circuit/Double/Multi Circuit Towers) during last Seven (07) years from the scheduled date of Bid submission in MSETCL or any other power transmission utility in India. The bidder should submit the experience certificates for satisfactory completion of above-mentioned work duly signed by the officer not below the rank of Executive Engineer or equivalent along with work order copies as above
III]	<u>FINANCIAL CRITERIA</u>
1	A declaration to the effect that the Bidder does not anticipate change in his ownership during the proposed period of the work till successful completion of warranty period (If such a change is anticipated, the scope and effect thereof, shall be defined) shall be submitted with the offer.
2	Income Tax Returns: The Bidder shall submit the copy of Income Tax returns for the last three financial year (i.e. . FY 21-22, 22-23 & 23-24), from the last day of month previous to the one in which Tenders are invited.
3	Note:- Notwithstanding anything stated above, the owner reserves the right to assess the bidder's capability and capacity to perform the work, should the circumstances warrant such an assessment in the overall interest of the owner and may reject the offer without assigning any reason.

(B) Price Bid (Part – II) –

- Techno-commercial bid will be opened online for all received bids. After verifying the all documents / certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tenderer fulfils the desired prerequisites, the price bid will be opened online. If the same is not found to be meeting the prerequisite, the price bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
- This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
- The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately. In case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.
- The offer shall be valid up to 120 days from the date of opening of the tender.
- The estimated rates in tender document are inclusive of all taxes. **However, the bidder should quote rates exclusive of Taxes, etc. if any. The taxes should be quoted separately.**

(C). General Terms & Conditions

- 1 **AGREEMENT:** Within 07 days from the date of receipt of the LOI, the contractor shall enter into an agreement of Rs. 500.00/- with the MSETCL. The cost of stamp paper is to be borne by the contractor. After submission of agreement, the contractor will be called for scheduling the date of signing & execution of agreement in the office of Executive Engineer, EHV O & M Division Pimpri Chinchwad, Pune. Until the agreement is executed, the MSETCL will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor
- 2 **SECURITY DEPOSIT:-** The contractor will have to pay **Security Deposit of 10% of the work order value** within **7 days** from the date of issue of LOI in the form of FDR/B.G of any Nationalized/ scheduled Bank in the favour of “MSETCL” at the office of The Executive Engineer, EHV O&M Dn Pimpri Chinchwad Pune, valid for one year or online payment NEFT/RTGS. If you fail to do so, the SD will be recovered from your first bill with interest i.e. 18% applicable. The Security deposit will be refunded only after satisfactory completion of the Guarantee period. Also, you will have to apply for refund of SD within 6 months after completion of guarantee period. If you fail to apply within stipulated period, the action as per CO’s rules will be taken
- 4 **PERIOD OF CONTRACT:** The contract for the period of **12 Months** will be placed with the agency whose rates and offers are found suitable. **The undersigned however reserves the right to place the order for any shorter period and to terminate the order at any time if the services are not found satisfactory.**
- 5 **VALIDITY OF ENQUIRY:** -Enquiry shall remain open for acceptance for a period of 1 months from the date on which it is due for submission. During this period, no bidder shall be allowed to withdraw his enquiry. Any such withdrawal during the said period will entitle the forfeiture of the earnest money deposited by the bidders. As such the offer submitted by the bidder must have a **validity of minimum 120 days from the last date of submission of offer.**
- 6 **BIDDER’S QUOTATION: The estimated rates in Enquiry document are including of GST & Cess. However, the bidder should quote rates exclusive of all charges, Taxes, statutory charges, etc if any. The taxes should be quoted separately in the space provided in the SRM bidding system.**
- 7 **SUBMISSION OF ENQUIRY:** The enquiry should be submitted through SRM only. Bids submitted physically/ in hard copy will not be considered
- 8 **SUPERVISION OF WORK:** - The work should be carried out under the supervision of the AEE, Line Maintenance Sub-division, Pimpri Chinchwad. **The work should be executed as per instructions from the AEE, Line Maintenance Sub-division, Pimpri Chinchwad who will supervise the work. The work carried out without supervision will not be recorded and payment will not be released for such works which may please be noted.**
- 9 **SCOPE OF WORK:** -
 - a) Monkey patrolling should be carried out by Drone only.

- b) Work of Monkey Patrolling of various EHV Lines should be carried out by authorized person only, as circuit is live while checking of conductor, earthwire, earthbond, hardware, jumper cones and its nut bolt Bird guards, tightness of nut bolt of tower, visually flashover, birdsheet. Checking of broken/contaminated/flashover disc insulators, split pin, sag if any etc. along with submission of report including soft copy of photos.
 - c) Agency should be taken Date & Time enabled Photos by Drone Camera.
 - d) Each picture should be clear & visible. Bloor Picture is liable to reject.
 - e) The complete work should be carrying out in presence of In-Charge of Line Maintenance S/Dn Pimpri Chinchwad or his representatives.
- 10 The prior permission from the concerned Engineer-in-charge is to be taken by the Contractor before starting the work.
 - 11 **WORK COMPLETION PERIOD:** The work should be completed within 60 days from the date handing over of site as per instruction of Executive Engineer or Engineer Incharge.
 - 12 **VALIDITY:** validity of the order is upto one year from the date of issue of order or exhaust of order amount whichever is earlier.
 - 13 **MONKEY PETROLLING REPORT:** The monkey patrolling report should be submitted in format as per Schedule B. Along with the two sets of patrolling reports of each line as per attachment, there should be minimum **8 Nos. of digital photos of S/c towers, 12 Nos. for D/c towers and 14 Nos. on M/c towers** showing the details of all insulator strings, conductor Hardware's, stub conditions, Earth wire hardware's, details of it. Abstract of monkey patrolling shortfalls of each line should be prepared in format in a separate Excel sheet as per Schedule B. All such photos should be compiled tower and line wise and to be submitted in suitable size hard disc only to the AEE, Line Maintenance Sub-division, Pimpri Chinchwad.
- If monkey patrolling report submitted found incomplete that should be resubmitted by bidder at free of cost immediately or otherwise same will be deducted from your bill/S.D.**
- 14 **GUARANTEE:** The work done should be guaranteed for the period of 6 months from date of completion of work/handing over back to MSETCL. During this period, if any defects observed in photographs in respect of visibility & clarity, the same should be reattended by you with free of cost.
 - 15 **QUALITY OF WORK:** The contractor will be responsible for quality of work & workmanship. The contractor should provide recordiall photographs in hard disc and detailed analysis reports should be submitted as per Schedule "B" after completion of work. The photographs clarity should be maintained.
 - 16 **PERMISSION/LICENSE:** The permission/License from Police and Central/State Government authority i.e. DGCA (Directorate General of Civil Aviation) for use of drone camera should be obtained wherever required.

- 17 **VARIATION IN QUANTITIES OF WORK:** The work will be generally carried out in accordance with the instructions given at site. The Executive Engineer, Pimpri-Chinchwad Division or his representative reserves right to increase or decrease the quantities of work to be executed or deleted or add any items, part or whole thereof. *The payment will be done for the actual quantity of work done*
- 18 **FAILURE OF EXECUTION OF THE WORK:** For failure to execute the work as per given Schedule "A" against the order in part or full, within the stipulated period, the Company shall be at liberty, without further notice or reminder to the contractor to get the same work done on account of and at the risk & cost of the contractor and claim for the difference in price and for all expense whatsoever incurred in getting the said work done and the same shall be recovered from any payment due to the Contractor from bills or deposit or on any account with any MSETCL's Offices, such expenses will also include 15% Supervision charges & Security Deposit will be forfeited.
- 19 **PENALTY:**
- a. **Performance of work:** If it is found that performance of work is unsatisfactory, or not as per norms of MSETCL, the contract is liable for termination at any stage of work without giving any prior notice and at contractor's entire risk & cost. The security deposit paid by the contractor shall be forfeited in that case.
- b. **Delay in execution of work:** In case of delay in execution of work beyond work completion period, penalty @ ½ % per delayed week, maximum to 10% of order amount shall be levied on contract value. If the work is not carried out in the stipulated period, the works will be got done departmentally or through any other agency at your risk and cost even at higher rates, in addition to the penalty that shall be chargeable as mentioned above.
- c. **Penalty for partly completion of work:** In case the contractor fail to complete the work entrusted, partly or fully, the balance work will be carried out through other agency and difference in cost will be recovered from contractor's bill and S.D. & the over & above balance shall be recovered from contractor or else penalty will be charged, **maximum** up to 10 % of order value whichever is higher.
- d. To impose penalty in above (a), (b) & (c) case, for execution of work is discretion Engineer Incharge of Line Maintenance Sub Division under EHV O&M Division, Pimpri Chinchwad with due justification.
- 20 **VARIATION IN ORDER AMOUNT DUE TO VARIATION IN TAXES :-**
In case any existing GST or duties are enhanced or any tax or duty is newly introduced by Govt. Applicable for this work with effect from the next day of first working day of the calendar month just previous to the month of due date of submission of the bid and if the contractor is required to pay additional amount towards this tax or duty then the MSETCL shall reimburse the contractor, at actual, the additional tax or duty so paid by the contractor against submission by the contractor of documentary evidence to the satisfaction of the Owner. The breakup of prices & percentage of taxes and duties considered for quoting is to be

given in a separate schedule other than price schedule.

The above provision is applicable for any reduction in duty or tax from the next day of the first working day of the calendar month just previous to the month of due date of submission of the bid. Accordingly the contractor shall pass on the benefit due to reduction in duties and GST etc. to the Purchaser.

If any statutory variation regarding enhancement of existing tax or duty or introduction of a new tax or duty applicable for this work takes place in the extended period of contract, no claim for additional cost due to statutory variation shall be entertained by the Owner.

- 21 **SUBMISSION OF BILLS / PAYMENT OF BILLS:** The tax invoice/ if applicable E-Invoice along with Guarantee/ warrantee Certificat and monkey patrolling report signed by both parties & advance revenue stamp receipt should be submitted in triplicate to the AdEE, Line maintenance Sub Dn., Pimpri Chinchwad. Please quote PAN No. on the bill with bank details for RTGS/ NEFT Payment. The service entry of the bills will be done by concerned incharge in SAP. Scrutinizing & auditing will be done at Division Office. Payment will be effected within reasonable time & as per availability of funds at Division Office.
- 22 **RISK & COST:** - MSETCL does not take any risk and will not pay any compensation for fatal/ non-fatal accidents to persons deployed by the contractor for the work, while carrying out the work under contract nor anything will be paid towards damages to the contractor vehicle/T&P etc. If any accident occurs to any of worker/ Supervisor/or outsiders during the work, the same will be on the contractor's account & if any expenditure is done towards medical aid that can be recovered from the contractor bill. MSETCL will not be responsible for such accident/ compensation payment etc.
- The works whether fully completed or incomplete, all the materials, machinery, T&P temporary building, and other things connected therein shall remain at the risk and in the sole charge of the contractor until the completed work has been handed over to the Engineer In-Charge and till completion certificate has been obtained from the Engineer In-Charge. Until such handing over of the completed work, the contractor shall at his own risk & cost take all precautions reasonably necessary to keep all the aforesaid works and other things connected therewith, free from any loss or damage. In the event of the same or any part thereof being lost or damaged, he shall reinstate and make good such loss or damage, at his own cost & risk.
- 23 **INSURANCE AND PAYMENT OF CONTRACTOR PERSONNEL:** Personnel employed by the contractor for execution of this contract shall be under Workmen's Compensation Act as required under the relevant provisions of the Contract (Labour/ Regulation and Abolition) Act 1979. It is whole responsibility of the contractor.
- 24 **SAFTY:** The contractor should ensure the safety of all the workmen, materials and equipment at work site. The contractor will be responsible for providing of all safety notices and safety equipment required. M.S.E.T.C.L will not be responsible for any accident or damages thereof due to contractor's worker's negligence on non-observance of our instructions. The contractor has to bear the compensation to their worker's in case of any accident.
- 25 **IDLE LABOR HOURS:** In case of suspension of work, or delay in work, non-sanction of outage due to any reason or stay order of the Court of Law no compensation will be paid by

the Company for idle labors /idle machinery etc., for that period.

- 26 Any breakage/damage occurred to MSETCL material/ Equipment / theft of material if any, asset during the work shall be recovered from the contractor bills as per rules.
- 27 The contractor will not be entitled to claim any interest on amount payable to them
- 28 **LOSS OF MATERIAL:** The contractor will have to keep their material in their safe custody. MSETCL will not be responsible for the loss of the material kept at MSETCL's site. The accommodation for the contractor's staff shall not be provided by the MSETCL.
- 29 **TOOLS AND PLANTS:** All kinds of Tools, plants, Tackles and machines etc., are to be arranged by the contractor at their cost. Company will not spare anything on this account.
- 30 **HOUSING & ACCOMMODATION:** The contractor will have to make their own arrangement for the housing of their staff and labours
- 31 **SITE CLEARANCE:** The contractor should, during the progress of work, keep the site reasonably free of all unnecessary obstruction and shall store the material neatly so as not to cause any obstruction for normal working / operations.
- 32 In case of any conflicting instructions or any difference of opinion about any point or in case of any dispute about this tender specification/contract/ work order for interpretation of any of the clause/terms conditions of this contract, the decision of the Executive Engineer, EHV O&M Dn Pimpri Chinchwad Pune about the interpretation of any terms and conditions will be final and binding on the contractor.
- 33 **TERMINATION OF CONTRACT:-** The undersigned reserves the right to accept or reject the tender in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days without assigning any reasons, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.
- 34 **TAXES:-** Income Tax & all other applicable taxes will be deduced as per prevailing rates from the contractor's bill, as per rule, if applicable. GST Number should be mentioned on the bill.
- 35 **HINDRANCE OF WORK:-** If the work has to be suspended due to any reason, shut down etc., the MSETCL shall not pay any compensation/ damage to the contractor towards items like labor, idle machinery, vehicle etc. however in such cases the contractor will be paid for the actual work executed by them under the supervision & measured by concerned engineer.
- 36 **SUB- LETTING OF CONTRACT:** The contract or any part thereof shall not be assigned, transferred, or sublet.
- 37 **FORCE MAJEURE:** Only the following conditions shall be considered for the purpose of this clause.
 - a) Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc.

- b) Acts of any Government, Domestic or Foreign such as war (declared or undeclared) Priorities, Guarantees Embargoes etc.
- c) The party affected by 'Force Measure' shall within 15 days of the occurrence of such a cause, notify the MSETCL in writing with sufficient documentary proof.
- d) Non availing/ non approving of outage due to system constraints

- 38 **APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:** All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding supply and work, which are not stated here, are also applicable to this contract.
- 39 **JURISDICTION:** All disputes or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE Court only.
- 40 **ACCEPTANCE OF TENDERS:** The Company does not bind itself to accept the lowest or any tender neither will any reason be assigned for the rejection of any tender.
