3. Documents should enclose with the offer for Technical Qualification.
 1. **Statutory Registration. (Statutory Licenses/Registration)**
 - 1.1 Proof of registration of firm under Bombay Shop & Establishment Act Valid Shop Act license mentioning providing/supply of security
 - 1.2 The bidder should be registered under GST (Goods & Service Tax) under GOI as well as for other various taxes in force & GST Returns for F.Y. 2023-24
 2. **Financial Criteria.**
 - 2.1 Income Tax Returns for the financial year 23-24 with Pan Card Copy.
 3. **Technical Experience criteria.**
 - 3.1. Manufacturer or Authorization Letter from Original Manufacturer
 - 3.2 The safety shoes must comply with requirements under Indian standard IS15298:2016 Agency should submit test certificate & test certificate of safety shoes must be as per ASTM F 2413 .
 - 3.3 The Sample approval of safety shoes to be obtained from Superintending EHV O&M Circle, Parli on or before due date of submission of bid offer. The copy of sample approval should be uploaded with bid offer.
 - 3.4 Bidder have to submit an undertaking in the attached proforma Schedule "G" declaring that their Firm is not Debarred/Blacklisted by Government/Semi-Government/Other Power Utilities, anywhere. If it is revealed that the participating Bidder is Debarred/Blacklisted by any Government/Semi-Government/Other Power Utilities, anywhere, the offer of such Bidder shall be liable for rejection at any stage of Tendering process. Further, if it is revealed that the successful Bidder is Debarred/Blacklisted by any Government/Semi-Government/Other Power Utilities, anywhere then order of such Bidder, shall be liable for termination at any stage of Order execution process and the concern Bidder shall be solely responsible for the consequences arising there from.
 - 3.5 The bidder should submit the Guarantee/warrantee certificate for minimum 01 year from date of supply of material.
4. The rates should be valid for 120 days.

5. The rates shall be quoted in the work schedules. Overwriting or conversions of figures correction and where unavoidable shall be made by Crossing out initiating, dating and rewriting.
6. No advance payment shall be made in any case. However, 100% payment shall be affected after satisfactory completion of work.
