# E-ENQUIRY

**Sub:-**Enquiry through Quotation basis for providing of expert & suitable agency for the stringing work of 0.4 ACSR zebra conductor on 220 kV Narrow Base Multi-Circuit Towers (Total 3 ckts. i.e. 9 Conductors) over the existing In-Service line i.e.132kV D/C MSETCL line by Hot Line EHV Crossing Method in the span between loc. no. 2A & 3A of 220kV M/C Bale-PGCIL (Kumbhari) line.

Sealed and superscripted quotations are invited for the work as detailed above with subject to following terms & conditions.

### TERMS & CONDITIONS:

- 1) The quotation may please be submitted in a sealed envelope super scribed as "Quotation for providing of expert & suitable agency for the stringing work of 0.4 ACSR zebra conductor on 220 kV Narrow Base Multi-Circuit Towers (Total 3 ckts. i.e. 9 Conductors) over the existing In-Service line i.e.132 kV D/C MSETCL line by Hot Line EHV Crossing Method in the span between loc. no. 2A & 3A of 220kV M/C Bale-PGCIL (Kumbhari) line., so as to reach this office **on or before 13.02.2025 up to 17:00 Hrs**. positively. In case of hand delivery, Quotation should be handed over to receipt clerk of this office. Quotations will be opened on the same day, if possible. M.S.E.T.C.L. will not be responsible in any manner for the postal delay of any type.
- 2) The rate should be provided as per schedule A format as enclosed with clear bifurcations of taxes.
- 3) The Total work amount should be limited to Rs. 10,00,000/- only (Rs. Ten Lakhs only).
- 4) The service provider should provide similar work experience certificate.
- 5) The offer shall be valid for acceptance for the period of **3** months from the date of submission.
- 6) The entire work as per the scope in schedule "A" is to be completed within a period of 30 days from the date of handing over of the clear site for work.
- 7) Following documents should be submitted with the offer :
  - i) PAN card,
  - ii) GST registration,
  - iii) Firm details
  - iv) Bank details etc.
  - v) Shop Act,
  - vi) Electrical Contractor License,
  - vii) Similar work experience

All above mentioned documents shall bear the authorized signature of agency, failing which the offer will be liable for rejection.

- 8) Taxes will be deducted as per applicable Govt. rule.
- 9) 220 kV Multi-Circuit line on which work of conductor stringing of 123 mtrs span is to be carried out is passing perpendicularly over/above the existing live circuits of 132 kV Bale-Mohol & 132 kV Bale-Chincholikathi line.
- 10) The material required for the stringing work viz. Conductor, Earth wire, Insulators and Hardware fitting, Spacers, Vibration Dampers etc. including Transportation from the site store to work place will be provided by MSETCL.
- 11) All the manpower/ gangs required for the aforesaid work for conductor stringing of 123 mtrs. Span is in the scope of agency.
- 12) The required T&P, vehicle such as tractors, tensioner & puller (if required), etc. is in the scope of agency.
- 13) If contractor fails to execute the order, it will be treated as breach of contract & contract will be terminated & order will be cancelled by forfeiting the Security Deposit.
- 14) Engineer in charge: The Additional Executive Engineer, EHV Lines Projects Subdivision, MSETCL, Solapur shall be the Engineer-in-charge for execution of this work
- 15) Accident &loss: If any accident is occurred to your staff during the execution of work, the whole responsibility lies on you. Also if any loss is occurred during the work to the MSETCL's property, the whole cost of equipments will be recovered from your bills or anywhere pending with MSETCL.
- 16) Contractor's Employees: Contractor should employ & provide only such employees who are skilled & experienced for execution & supervision of such type of works.
- 17) **PENALTY:-** If work is not carried out as per order within stipulated period, a penalty @ 0.5 % per week up to Maximum 10 % of total value of the order, will be payable by the Agency.
- 18) **GENERAL:-** Other terms and conditions of MSETCL are also applicable.
- 19) Jurisdiction of court: In case of dispute if any, legal jurisdiction of the Court shall be in Solapur only.
- 20) The undersigned has reserved the right to modify or cancel the order at any stage without assigning any reason thereof and without any liability on MSETCL.
