- **Quoted Rates:** The rates quoted should be including of all taxes, charges, etc. 3)

# 2. Technical Qualifying Requirement/Criteria:

- I. The bidder should have in last **07 years experience** of "Similar work" i.e. work of Reconnaissance Survey and Detailed Survey for EHV lines in organization MSETCL or other Govt/Semi Govt. for amounting as follows:
  - a. One completed work mentioned above having costing not less than the amount equal to 70% of the estimated amount, OR

# 3. Financial Qualifying Requirement/Criteria:

- i. The Average Annual turnover of the bidder during last 3 financial years should be not below than **50**% of estimated cost.
  - The bidder should submit the certificate of turnover through <u>Unique Document Identification Number (UDIN)</u> duly certified by Practicing Chartered Accountant for preceding (last) 03 financial years on the basis of audited financial statement
- ii. The bidder should have a "Net Worth" (which is defined as "Equity share capital + Reserves Revaluation reserves Intangible assets Miscellaneous expenditure to the extent not written off and carry forward losses") of not less than 20% (Twenty percent)

## 4. Other Mandatory Documents For Valid Bid:
