- 5. Mandatory Terms & Conditions
 - a) The minimum of 1800 Km/ month will have to be borne by vendor including (Hiring Charges +Fuel +Driver) in rate quoted at sr. no. 1 in Schedule 'A' above.
 - b) The Km run above 1800km in month will be considered as extra Km and charges will be paid accordingly as per sr. no. 2 in Schedule 'A' above.
 - c) The vehicle must comply with working A/C at all times during duty Hrs.
 - d) The major/minor repairs & driver's expenditure will be borne by the owner. Also the Consumable/ wearable item such as wind shield wipers/tyres/brake pads must be maintained.
