Name of work: Work of Supply and erection of new bore well submersible pump at 220KV Malharpeth Substation under EHV O&M Division, Karad.

TERMS & CONDITIONS:

- **1. DUE DATE: -** The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either in person/post on or before **Dtd. 20.02.20205 upto 18:00 Hrs** positively.
- **2. DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :-** Please submit the following documents along with offer :
 - 1. Registration under PAN & GST.
 - 2. Registration under Bombay Shop & Establishment Act/NOC from local Grampanchayat.
- 3. ESTIMATED COST: The estimated cost is limited upto Rs. 32,982/- including of all.
- **4. QUOTED RATES**: The quoted rates should include the cost of all taxes. The taxes will be clearly mentioned, & if the taxes are not clearly mention, then it will be presumed that the rates are inclusive of all taxes.
- **5. VALIDITIY OF OFFER: -** The offer should be valid for acceptance for a period of **90 days** form the due date of same.
- **6. SCOPE OF THE WORK:-**The scope of work is as per mentioned in Schedule 'A'.
- **7. AGREEMENT:** -You have to execute Indemnity cum agreement bond on stamp paper of **Rs. 500/** in prescribed format at your cost.

- **9. COMPLETION PERIOD: -** The work should be completed within **3 Months** from the date of receipt of the LOI/WO.

- **16. BILLS:-**You will have to submit the bills in triplicate to this office as per the specifications mentioned in Schedule 'A'. The bills submitted should be in the name of Office of the **Executive Engineer**, **EHV O&M Division Karad** (**GST No.27AAECM2936N1Z2**) at EHV O&M Dn Karad.

After duly recorded by the concerned S/Stn Incharge, the same will be reflected subject to availability of funds at Division office. Please quote your GST No. & SAC Code for the Service availed by you on bill for smooth payment.

- **17. PAYMENT:** 100% payment against the bills for the work actually carried out will be given to you after deducting necessary taxes & duties as per Govt. Rule either by cheque or NEFT/RTGS.
- **18. PENALTY: -** If the work/supply of material is not completed within the stipulated time period the penalty will be charged as per prevailing rate i.e.1% of the order value per week of delay maximum upto 10% of the total order value.
- **19.** The work should be strictly executed as per the Schedule enclosed & as per instructions of the concerned authority assign by the Ex. Engineer or his representative deputed for this work.
