- 1) Name of work: Providing diesel vehicle (Tata Sumo/Bolero equivalent or above) on hire basis for carrying out PID testing works of EHV lines & sub-stations under EHV O&M Circle, Karad.
- 2) The vehicle must be with valid RTO tourist permit and valid for the period of contract. The vehicle model having registration within 05 years will be preferred. Fitness certificate is required.
- 3) Only Diesel will be supplied and Toll charges will be paid by the MSETCL.
- 4) The vehicle will be utilized on any day throughout the contract period as per the requirement of undersigned.
- 5) The vehicle will be utilized for works other than PID Works, when PID work is not possible/scheduled.
- 6) You will have to pay the security deposit of 5% of the order value within Seven days from the date of receipt of firm order.
- 7) The quotations should reach to this office on or before 24th Feb 2025 up to 16:00 Hrs.
- 8) Payment will be made per month basis after satisfactory completion of work subject to availability of funds.
- 9) The right to reject any or all quotations is reserved by the undersigned.
- 10) The quotations not confirming to the specifications are likely to be rejected.
- 11) The quotations should be properly sealed and super-scribed on the envelope as "Providing diesel vehicle for carrying out PID testing works of EHV lines & sub-stations under EHV O&M Circle, Karad."

Note:

- 1) Period of contract: One year from the date of actual engagement of the vehicle.
- 2) The above rates are excluding of GST, hence GST should be quoted separately, if applicable; otherwise it will be presumed that your rates are inclusive of all taxes.
- 3) The average consumption of the vehicle given on hire basis should be 12Kms/Ltr irrespective of actual average of the vehicle. If the average consumption is less, the proportionate amount will be deducted from your bill.
- 4) Only Diesel will be supplied and Toll charges will be paid by the MSETCL.
- 5) The normal duty hours will be from 9.00 to 19.00 Hrs; on every working day. However per day rate will be treated for 10 Hrs; and extra hours will be considered as O.T hour; however, either O.T or halting charges whichever is less will be paid on a particular day.
- 6) At the time of submitting the quotations, the vehicle shouldn't have been engaged at any other place.
