# **General terms & conditions**

- 1. Rates quoted should include provision of Driver, Diesel required for all instructed trips, his salaries & allowances, Water Tanker maintenance, Taxes, and all other charges etc. No extra charges will be paid other than quoted rate by MSETCL.
- 2. Bidders should strictly follow norms & safety measures prescribed by RTO for Supplying Water Tankers for water services.
- 3. The order is limited to the period of half year or till the order value exhausts, Limited amounting Rs. 2,00,000/- (including all taxes)
- 4. The work contract tax if applicable will be deducted from your Bill as per rule

- 5. The Company will not be responsible for any kind of accident or damages to the Water Tanker or its driver during the hired period. All the financial liabilities arising out of accident shall be borne by the owner of Water Tanker.
- 6. The working hours will be normally from 07.00 Hrs to 19.00 Hrs or as and when required per directives of undersigned.
- 7. Any kind of Water Tanker breakdown should be attended by owner. No charges will be paid by Company during breakdown. Agency will have to provide alternate Water Tanker during breakdown at same rate.
- 8. According to financial act, income tax will be deducted from your bill& certificate to that will be issued to you.
- 9. The rate quoted should be firm & price variation will not be acceptable. Rate should be inclusive of all taxes & other incidental charges.
- 10. Driver should be managed by Water Tanker owner. He should have valid license to drive such type of Water Tanker and. Driver should not have any criminal record & NO FIR should be registered on him. Driver should not found with any type of alcoholic drunk during Working hours.
- 11. All the rules regarding registrations of Water Tanker, sales tax, GST tax & other Govt. taxes etc should be borned by Water Tanker owner.
- 12. If it is found that Water Tanker is not giving satisfactory service, the contract is liable for cancellation after giving 24 Hrs notice.
- 13. **Scope of Work:** Supplying Water Tankers for watering to switchyard equipment earthing on as and when required basis at 400kV RS Dhule under 400KV RS Dn Dhule.
- 14. **Quoted Rates:** The rates quoted should be including of all taxes, charges, etc.
- 15. **Security Deposit:** The successful bidder will have to pay an amount equivalent to **10%** of Contract value towards S.D. to the office of the Exe.Engineer,400KV R.S. Dn. Dhule within 7 days from the date of receipt of LOI which is refundable after satisfactory completion of guaranty period.

<u>Technical bid (Qualifying Requirement):</u> Bidder should upload the following digitally scan copies of original documents / certificates online in 'note & attachments' tab in RFx.

### 1. Statutory Qualifying Requirement/Criteria:

- a. The Bidder should have a valid registration under <u>Bombay shop & Establishment Act 1948/</u> Small Scale Industry Act / Company(Factory) Act or Grampanchayat NOC as applicable Proof thereof.
- b. The Bidder should be Register under <u>Goods & Services Tax (GST) Act</u> Proof thereof or Undertaking.

Note: The original colored scan copy should be uploaded as bid documents in support of statutory qualifying criteria i.e. statutory licenses/registration. The attested / notarized photo copies of the same will not be entertained.

#### 2. Technical Qualifying Requirement/Criteria:

### Documents required of Water Tanker such as :-

- a) Valid shop act & establishment registration/grampanchayat NOC as applicable.
- b) Documents of Water Tanker such as RC/TC book, valid Driving license, capacity of Water Tanker (Min.), RTO Water Tanker permit (if any), insurance, fitness certificate.

- d) The experience bidder of similar work, should be preferred.
- e) If validity of any license / certificate expires during order period, you will have to renew the same and submit the copy to this office
- f) The owner reserved the rights to accept / reject the Bid.

#### 3. Financial Qualifying Requirement/Criteria:

i. The bidder should submit the Copy of IT returns for last 3 Financial Years and PAN Card.

The duly audited, verified and certified figures from chartered accountant will be considered for annual turn over and net worth. The provisional certificates (if any) will be not be entertained.

#### 4. Other Mandatory Documents For Valid Bid:

i. EARNEST MONEY DEPOSIT (EMD): online Mode only

The bidder should have to submit the <u>proof regarding payment of SRM E-Enquiry fee & E.M.D.</u> @1% of estimated cost.

**c.** In the event the bidder withdraws his offer during the validity period the earnest money deposit shall stand forfeited and the Purchaser shall be entitled to recover the amount of E.M.D. paid or encashing the Bank guarantee or by resorting any other remedy available under the law.

<u>Note for SSI unit</u>: The bidder registered with Directorate of Industries of Government of Maharashtra for manufacturing the items tendered/offered and those who have attached valid Certificate at the time of vendor registration shall be considered for concessions applicable. These benefits shall be available only to those items approved during the Registration process and subsequent updates in registration up to the submission of this SRM E-Enquiry.

- 14. The work shall be supervised by the Engineer, appointed by under signed and it should be carried out to the satisfaction of Engineer In-charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- **15. Liquidated Damages / Loss due to theft**: Any damage or loss to M. S. E T. Co.
