E-Enquiry

<u>Sub</u>: Cleaning, sweeping and carrying out housekeeping activities at office of the EHV, CCCM Division, and Solapur.<u>Inviting of quotations thereof.</u>

E-enquiry is invited for above work as per the Schedule 'B' attached so as to reach this office on or before 20.03.2025 up to 15.00 hrs. The enquiry will be opened on the same day if possible.

TERMS AND CONDITONS:

- 1. Work is to be done at EHV, CCCM Division, Solapur.
- 2. Work is to be completed within 12 months from the date of handing over of site or up to exhaustion of P.O. amount.
- 3. E-enquiry mentioned in Schedule 'B' are approximate and payment will be made on actual quantities of the work executed.
- 4. Payments will be made in R.A. bills or only first and final bill at the discretion of Engineer in charge as per availability of funds.
- 5. Our rates are inclusive of all GST will be recovered from your bill as per Government rules at prevailing rates.
- 6. Rates quoted should be inclusive of all T & P labour etc.
- 7. Work is to be carried out strictly as per the standard specification and as directed by the Engineer in charge. Mode of measurements will be as per P.W.D. practice.
- 8. In case of any dispute, the decision of the Executive Engineer (C) Solapur will be final and binding on the contractor.
- 9. If any damages occur to the Company's property, during execution, contractor will have to make them good at his own cost.
- 10. Agency has to attach Xerox of PAN Card, Registration Certificate, EPF certificate, G.S.T. certificate etc. and all necessary documents along with the e-enquiry.
- 11. Income tax as applicable as per Government rules at prevailing rates on basic amount of bill will be recovered from your bill, in case the ordered value exceeds Rs. 5000/-. Work contract tax and will be deducted as per Govt. rules.
- 12. All terms and conditions as per the Company's rules including those mentioned in the booklet, Tender and contract for works are applicable in this case also.

- 13. Right to reject any or all quotations without assigning any reasons is reserved by the undersigned.
- 14. Contractors will have to pay Rs. 2,000/- as E.M.D. Quotations without EMD are liable for rejection. The E.M.D. is to be paid by Cash only.
- 15. Contractors are requested to visit/inspect the site before submitting their quotations.
- 16. Contractors will have to pay Rs. 10% S.D. on value of the work order, if the work order exceeds Rs. 5000/- in the form of Bank guarantee or F.D.R of Nationalized Bank prior to starting of work.
- 17. The rates quoted should also be written in words.
- 18. Over writing, corrections if any shall have to be initialed by the contractor.
- 19. Contractors will have to enter into agreement bond on stamp paper of Rs. 500/- before the start of work.

20. ADDITIONAL SECURITY DEPOSIT-

If the bidder quote below the estimated rate "Additional Performance Security" as specified below is required to be deposited within period of ... (12) days from the date of issue of LOL in the form of Cash / Demand Draft / FDR/ Bank Guarantee (Hard copy) in Company Standard Proforma for a period of contract. Demand Draft / FDR/ Bank Guarantee should be of Nationalized bank/Scheduled Bank drawn in the name of Executive Engineer, EHV CCCM Division, MSETCL Solapur. The period of the additional security deposit should be extendable up to expiry of valid extension, if any, as directed by Engineer-in-charge. The bidder should note that this time limit of 10 days will not be relaxed /extended for any reason. Non-submission of above additional security deposit within 10 working days will also result into penalty of 18% interest along with GST. Same will be recovered from RA/Final bills.

This additional Security deposit will be separate from the regular 10 % SD to be deposited against maintenance/liability period.

- i) If the lowest bid is below up to 10% of the estimated cost put to tender, then the bidder/contractor shall submit additional SD as a Performance Security equal to 1% of the cost put to tender (e.g. from the bidder who has quoted 1% to 10% below to the estimated cost, ASD = 1% of Estimated cost put to tender).
- ii) If the lowest bid is more than 10% to 15% below of the estimated cost put to tender, then the bidder/contractor shall submit additional SD as a Performance Security equal to the percentage over and above 10% and as per above (e.g. If Bid Offer of 14% below, up to 10% below-1% and 14%-10%=4%, thus total ASD = 1%+4%=5% of estimated cost put to tender).
- iii) If the lowest bid is more than 15% below, then additional SD as a Performance Security the bidder is required to pay amount for the balance percentage over & above 15% be worked out at double rate (e.g. if the offer is 19% below, then (19-15=4% x2=8%). The total ASD will be 1+5+8=14 % of the estimated cost put to tender.
