TERMS & CONDITIONS:

- 1) The quotation is to be submitted to the office of Executive Engineer, 400 kV RS Division, Thaptitanda, subscribing on the envelope with writing “Quotation for hiring of diesel Light Motor Vehicle (LMV) with valid license holder driver for the Additional Executive Engineer, 400 kV LMSD Thaptitanda” and should reach to mentioned office address **on or before 16.03.2025 18:00 Hrs**
- 2) **The period of Contract will be 01.04.2025 to 31.03.2026.**
- 3) Amount of monthly expenditure is limited to **Rs.50000 (Fifty Thousand only), including hiring and fuel charges.**
- 4) Fuel (diesel) will be provided by MSETCL as per requirement.
- 5) The payment will be made on Monthly basis. Payment will be made after submission of bill, the payment against this contract will be effected by MSETCL within reasonable time as per funds availability.
- 6) Vehicle should be **Light Motor Vehicle (LMV)** and give minimum **average of 12 km per liter** (In Words Twelve Kilometer per liter) otherwise recovery will be made for excess fuel consumption.
- 7) Security Deposit: Security deposit of 5 % of work order value to be paid within 15 days as per order terms and conditions.
- 8) Following documents are required with quotation:

- a) Valid Shop Act License.
 - b) Valid GST Registration Number (Optional).
 - c) Valid Pan Number.
 - d) Vehicle Registration Certificate.
 - e) Valid Vehicle Permit.
 - f) Valid Vehicle Fitness Certificate
 - g) Driver with valid driving License
 - h) Valid Vehicle insurance
 - i) Valid PUC Certificate
- 9) **Vehicle should be registered on or after 01.04.2021.**
- 10) All the liabilities against statutory provisions and loss/damage due to accident/theft etc. will be at responsibility of the vehicle owner.
 - 11) The vehicle should be registered as a public service vehicle and is also **covered by valid contract carriage permit.**
 - 12) Vehicle should be available with valid license holder driver on 24*7 basis, as and when required.
 - 13) Jurisdiction of Vehicle use will be in all over Maharashtra.
 - 14) Alternative arrangement should be provided when the vehicle is under breakdown/repairs, alternative vehicle shall be hired and expenses of the same shall be recovered from you.
