In case of the postal delay of any type, the M.S.E.T.C.L. will not be responsible in any manner. Quotations will be opened on the next day at 12:00 Hrs. if possible.

The contractor shall pay EMD of Rs. 3000/- along with the Quotation. E.M.D. payment will be accepted in the form of Cash at EHV CCCM Division M.S.E.T.C.L. Akola. As Earnest Money deposit which will be refunded after placement of the order & deposition of security deposit, if after placement of order, taxi is not provided on hire basis then the amount of Rs. 3000/- will stand forfeited. The amount will be refunded to those whose quotations are not considered for placing order.

The blank quotation form will be available in the Office of Executive Engineer (C) CCCM Dn. Akola from 06.03.2025 to 13.03.2025 on working days from 11.00 AM to 17.00 Hrs. after verifying the vehicle's documents.

The contractor should submit attested Xerox copies of all documents as given as per following terms & conditions at sr.no.6 along with the quotation. Right to split up the work or to reject any or all the quotations without assigning any reason thereof is reserved by the undersigned.

Terms & Conditions:-

- 1. All terms & conditions mentioned in the works & contract regarding to MSETCL are applicable.
- The estimated cost of work is Rs. 3,50,000/- only excluding of All Taxes & cost of Diesel/Petrol.
- The work contract shall have to be completed within a period of 12 Months from the date of instructions
 to start contract (i.e. from Dtd. 01.04.2025 to Dtd. 31.03.2026 or limited to value of work order
 whichever is earlier.)
- Care shall be taken that the total expenditure per month including cost of vehicle days plus cost of Diesel/Petrol for individual month for the hired taxi vehicle should not be exceeded Rs. 50,000/-per month (Rs. Fifty thousand per month only).
- No Lubricants will be supplied to the taxi owner.
- The Contractor should submit attested Xerox copies of the following documents for official record.
- Contractor should submit the self attested true copy of certificate of registration of Vehicle along with All India National Permit.
- Attested Xerox Copy of R. C. Book / T. C. Book.

- e. Partnership deed if it is a partnership firm.

- g. GST registration as per rules. (If registered)

- The Contractor should have to submit 01 (one) years experience certificate from previous any Government Department/PSU/State Government Undertaking employer mentioning such vehicle along with registration number served the service.
- The contractor shall be responsible to abide all prevailing labour laws including Workmen's Compensation
 Act.
- 9. The contractor shall be responsible for any accident/damage caused during execution of work & he shall have to make good of the same at his own cost as directed. MSETCL will not be responsible for any fatal or non fatal accident to the person of the agency. The Agency will be responsible for any fatal or non fatal accident to the person of the agency.
- 10. The payment shall be made on R.A. Bills/Final bill.
- You would have to make good all defects developed in the vehicle and also generally maintain the vehicle in good condition during the contract period.
- The normal working hours will be in between 9.00 to 21.00 Hrs. or as directed by the Addl. Executive Engineer (Civil), EHV CCCM Sub-Division, Washim.
- 13. Responsibility of parking is of taxi owner.
- In case of frequent failure / unsatisfactory services of the vehicle, the contract will be terminated by giving only 24 Hrs. Notice.
- 15. The vehicle will be required on all working days in each calendar month or as and when required by competent Authority.
- 16. The cost on account of maintenance / repairs, Drivers Wages/ allowances & vehicle taxes etc. if any shall have to be borne by the owner of the vehicle.
- 17. Payment of the particular day will not be done if Company's work is held up due to failure or breakdown of vehicle on that particular day.
- 18. The R.T.O., Police Department liabilities & other legal liabilities on account of accident etc. will be at the cost & account of owner of vehicle.
- 19. Term of payment: Payment will be made by A/C payee cheque on monthly basis as per rule by this office, after submission of printed bill form in triplicate by the agency through concern division office / sub-division office to this office.
- No overtime will be paid for excess working hours, if utilized for any day and no halting charges will be paid.
- Jurisdiction: Any dispute or difference arising out of or any in connection with this Tender/ Quotation or contract as since concluded shall be subject to exclusive jurisdiction of the Akola Court only.
- 22. Deduction: The Company shall be entitled to deduct / recover the amount of liquidity/ the amount incurred on account of minor repair/Tyre puncture etc on road; from the current bill payable to you or from any other amount due for payable to you, against any other contract.
- 23. The Toll Tax will be paid by the department.
- 24. SECURITY DEPOSIT:-The successful Contractor / Contractors shall have to pay Security Deposit amounting to Rs. 17,500/- (Rs. - Driver should posses the valid license to run the vehicle.

- 27. The quantities and estimated cost mentioned are approximate and liable for variation.
- 28. The contractor should have to submit Character Certificate of the Vehicle Driver to be appointed, mentioning no bad habits and bad performance.
- 29. GST will be applicable as per Government rule.
- 30. It will be sole responsibility of the contractor to incur the liability of statutory obligation and to make the payments to the concerned Government Authority.
- 31. Only the total quantity of the Diesel/Petrol work out as per the total run divided by the average will be provided by the company at company's cost.
