

A) Requirement and Technical Specification of Insulating Mat

The Insulating Electromat IS: 15652:2006 w.e.f. 01 November 2007 as per Govt. of India Gazette Notification No. S.O.2086 Dated 17 July 2007. It should have features as follows-

- a. High Voltage Insulated Mats of various Thickness with High Di Electric strength upto 65000 volts (i.e. 65 KV).
- b. Fire Retardant

- c. Excellent Mechanical properties to with stand load and movement of Breakers, Trolleys associated electrical equipments.
- d. No adverse effect of Acids, Alkali & Transformer oil.
- e. permanently pasted in front of electrical panels & equipments.

B) ELECTROMAT TECHNICAL SPECIFICATIONS: -

- c) INSULATION MAT WOULD BE 100% SHOCK PROOF UNDER LEAKAGE CURRENT OF 10mA.
- d) INSULATION MAT WOULD BE FIRE RETARDENT, WATER AND MOISTURE PROOF.

- m) INSULATION MAT WOULD HAVE LIMITING OXYGEN INDEX (LOI) OF MINIMUM 30 AS PER IS: 13501.
- n) THE INSULATION MAT SHOULD HAVE INHERENT INBUILT GLOW BANDS ON THE BORDERS FOR EXTRA SAFETY AND VISIBILITY IN THE DARK.
