Online bids are invited in two bid system for supply of T&P at various S/S under EHV O&M Division-1,Pune on or before **18.03.2025 upto 11:00 Hrs.** on following terms and conditions:-

**TERMS AND CONDITIONS:-**

**Submission of bid**

Two bid system should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-Enquiry website <https://srmetender.mahatransco.in>

**A. Techno –Commercial bid:**

This should contain following documents certificates (all self attested copies) as a proof of qualifying pre-requisites, brochures, attested certificates etc.

- Copy of valid shop act & establishment registration/NOC of Grampanchayat/Udyog Adhar.
- Copy of Pan card.
- Valid registration under GST .
- Work experience certificate of similar type of work executed under MSETCL/MSEDCL/Govt. Sector/Semi Govt. Section/Private organization.
- ITR for the AY year 2024-25

**If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.**

**B. Commercial bid:-**Bidder should upload the digitally signed price bid under commercial bid online.

- Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tenderer fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Bids with incomplete details or not submitted in prescribed form etc. are liable to reject.
- This office reserves all the rights to reject any or all Bids without assigning any reasons thereof.

- c) The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.
- d) The estimate rates given by this office are inclusive of taxes. However, the bidder should quote rates exclusive of all taxes. The taxes should be quoted separately.

#### **TERMS AND CONDITIONS:-**

**1. VALUE OF THE WORK :-** The value of the work is limited to **Rs.9,99,833/- (Rs Nine Lakh Ninety Nine Thousand Eight Hundred and Thirty Three Only)(Including Taxes).**

#### **2. SCOPE OF WORK:-**

Supply of T&P at various S/S under EHV O&M Division-1, Pune Strictly as per specification mentioned in Schedule "A".

**3. VALIDITY OF THE OFFER :** The offer submitted by the bidder must have a **validity of minimum 90 days from the date of opening of Price bid.** The bidder should submit their offer online complete in all respects before the submission date.

**4. SECURITY DEPOSIT :** The contractor have to pay the security deposit of 10 % of value of work order at EHV O&M Division-I, Pune within 07 days from placing of the work order. The security deposit can be paid by Cash/ NEFT/RTGS/Online payment/DD/BG/FDR in favour of Executive Engineer, EHV O&M Division-I, Pune.(GTC clause No. 6.9 is applicable)

In case of DD/BG/FDR, the validity shall be upto 90 days from the due date of completion of work.

The security deposit will be refunded after completion of Garranty period and by obtaining NOC from Addl.EE SS Maint. S/Dn. Pune.

**Please note that the % of security deposit clause of the work order may vary as per rules and guidelines issued by MSETCL/Government from time to time and same will be binding on you.**

**5.SAMPLE APPROVAL:** The Contractor have to get sample approval from The Executive Engineer EHV O&M Division-I, Pune before supplying the material at SS Maint. S/Dn.-I, Pune under EHV O&M Division-I, Pune. The sample shall be submitted within 07 days from the date of issue of work order.

**6.SIGNING OF CONTRACT/AGREEMENT:** **The contractor shall enter into an agreement on Non Judicial Stamp paper amounting Rs. 2000/- (As per estimated Amount) with the MSETCL within 07 days from the date of receipt of the work order.** The MSETCL will not be liable to pay nor shall the contractor be entitled to claim amount due or payable under the contract until the agreement is executed. The necessary stamp duty for the agreement shall be borne by the contractor.

**7. WORK COMPLETION PERIOD :** **The supply of T&P shall be done within 15 days from the date of issue of work order.**

**8. START DATE OF WORK:** Date of issue of work order will be considered as start date.

**9.GUARANTEE PERIOD :** The bidder will have to give the Guaranty of above material up to period of 12 months from the date of supply. Guarantee certificate shall be submitted by the contractor. Any defects developed during guarantee period should be rectified at the cost of contractor.

**10.WORKMANSHIP AND MATERIAL :**

All materials used by the manufacture shall be high graded, free from defects and imperfection. **Standard Make/standard manufacture/ISI mark manufacture & unused material shall be accepted.** Material Supplied by bidder should be inspected by Executive Engineer OR his representative before supply. If Material is not as per MSETCL Standard & Specifications, then said material liable to reject.

**A.** Minutes of meeting shall be recorded; for material to be supplied, duly signed by the contractor & the owner or his representative/operating officer of MSETCL.

**B.** Material shall be inspected & approved as per the specifications by the EE or his representative/operating officer.

**C.** MRC/MOM shall be submitted along with the bill. The prescribed formats will be issued with the final work order.

**11.PENALTY :**

**A) Delay in execution of work:** If the contractor fails to supply the material in all respect in stipulated time as mentioned above, he will be liable to pay penalty at rate of ½ % per day subject to maximum limit of 10% of the total value of the order.

**B) Delay in starting the work:** If it is found that the contractor fails to execute the agreement / start the work within stipulated time period, the contract is liable for termination by giving 3 days prior notice and at contractor's entire risk.

**12.TERMINATION OF CONTRACT WITH RISK & COST :** If the agency fails to supply the material fully or partly, within the stipulated period, the Company shall be at liberty, with prior notice of 3 days, to get the work done on account of and at the risk and cost of the contractor. MSETCL will prefer a claim for the difference in price and for all expenses whatsoever incurred in getting the same work. The said claim shall be recovered from any payment due to the Contractor from MSETCL, i.e. from bills or deposit or on any account; such expenses will also include 15% Supervision charges. The owner reserves the right to terminate/cancel the contract, in the event of the breach of contract in any respect or undue delay in execution of work/starting of the work.

**13.OPERATING OFFICER :-** The Addl.EE SS Maint. S/Dn. Pune will be operating officer. The operating office shall inspect the material as per MSETCL standard. The agency have to supply material at SS Maint. S/Dn-I, Pune.

**14. SUBMISSION OF TAX INVOICE :** The tax invoice shall be submitted to the Executive Engineer, EHV O&M Division-I, Pune as per Schedule 'A'. The bills must be submitted along with Material Receipt Certificate signed by both parties, Guarantee certificates of work and material from the successful bidder. The payment will be effected by Division office accordingly, subject to availability of funds after receipt of the bills also

**1. PAYMENT TERMS :** 100% payment will be done after the work completion per occasion and on the submission of Tax Invoice as mentioned in Cl No. 14 above.

**2. MODE OF PAYMENT :** The payment will be disbursed vide RTGS / NEFT by Division office.

**15.DEDUCTION OF TAXES :** Income Tax TDS @ 2 %, , GST TDS @ 2% & labour cess @1% will be deducted from the contractor's bill as applicable.

**16.STATUTORY VARIATION IN TAXES AND DUTIES :**

A) In case any existing taxes or duties are enhanced or any tax or duty is newly introduced by Govt. applicable for this work with effect from the next day of first working day of the calendar month just previous to the month of due date of submission of the bid and if the Contractor is required to pay additional amount towards this tax or duty then the Owner shall reimburse the Contractor, at actuals, the additional tax or duty so paid by the Contractor against submission by the Contractor of documentary evidence to the satisfaction of the Owner. The breakup of prices & % of taxes and duties considered for quoting is to be given in a separate schedule other than price schedule specified in this bid specification. **Rates quoted without separate breakup of price schedule shall be treated as firm rates and no variation on account of increase in taxes shall be payable. However, in case of reduction in taxes / duties, the reduction in rate shall be worked out considering quoted price includes that particular tax /duty.**

B) The above provision is applicable for any reduction in duty or tax from the next day of the first working day of the calendar month just previous to the month of due date of submission of the bid. Accordingly you shall pass on the benefit due to reduction in taxes and duties etc. to the Purchaser.

C) If any statutory variation regarding enhancement of existing tax or duty or introduction of a new tax or duty applicable for this work takes place in the extended period of Contract, no claim for additional cost due to statutory variation shall be entertained by the Owner.

D) The claims against statutory variation, if payable, would be settled as reimbursement of payment at actual. While submitting such claims, the Contractor shall include documentary evidence to establish that the extra amount claimed by the Contractor due to statutory variation was in fact paid by him solely on account of such statutory variation. This may vary from case to case depending upon the nature of statutory variation.

**17.RECOVERY :** Whenever any recovery towards losses/damages/shortages etc. is applicable; the same shall be recovered from contractor's bill, as assessed by the owner or his representative / Operating officer / Engineer-In-Charge. Recovery other than mentioned in work order placed to successful bidder will be done after consent of both parties.

**18.FORCE MAJEURE :** Only the following conditions shall be considered for the purpose of this clause.

- a. Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc.
- b. Acts of any Government, Domestic or Foreign such as war (declared or undeclared) quarantines, embargoes

The party affected by 'Force Measure' shall within 15 days of the occurrence of such a cause notify the MSETCL in writing with sufficient documentary proof. The Contractor or the

Owner shall not be liable for delays in performing their respective obligations resulting from any force majeure causes as defined above. The date of completion will be extended by a reasonable time by mutual agreement.

**19. SUBLETTING THE CONTRACT :** The contract or any part thereof shall not be assigned, transferred, or sublet without the prior written permission of the undersigned. Even if such permission is granted, it shall be responsibility of the principal contractor to whom the work order originally issued to execute the works as per the terms of the contract.

**20.DETAILS CONFIDENTIAL:** The Contractor shall treat the Contract and everything contained therein as private and confidential. In particular the Contractor shall not publish any information, drawing or photograph concerning the works and shall not use the site for the purpose of advertising except with the written consent of the Engineer and subject to such conditions as he may prescribe.

**21.JURISDICTION :** All disputes, differences related to the SRM Enquiry contract shall be subject to the exclusive jurisdiction of Pune District Court.

**22.COMPENSATION:** If any accident occurs to any of your worker / your Supervisor / or outsiders while carrying out the work, same will be on your account. The MSETCL will not be responsible for such accident/ compensation payment etc.

**23.LOSS OF MATERIAL:** You will have to keep your material in safe custody at your end. The MSETCL will not be responsible for the loss of the material kept at MSETCL's site. The accommodation for your staff will not be provided by the MSETCL.

24.The contractor shall have to make his own arrangement for Transport of man power, tools.

**25.IDEAL LABOUR HOURS:** In case of suspension of work or delay in work due to any reason or stay order of the Court of Law etc., **no compensation will be paid by the MSETCL against idling of labours / idling of machinery etc., during the period.**

1. In case of any dispute whatsoever, regarding interpretation of the terms and conditions, or quality, the decision of the Executive Engineer, EHV O&M Division I Pune will be final and binding on the contractor.

2. Notwithstanding anything stated here, all other Standard Terms and conditions prescribed by MSETCL, regarding supply and works, which are not specifically stated here, are also applicable to this contract and shall also form a part of the contract and shall be binding on the successful bidder.

3.The undersigned reserves right to Accept/Reject/Cancel the above SRM Enquiry without assigning any reasons thereof. Irrelevant documents if attached the bidder may be liable for rejection which may please be noted.

**26.Income tax:** If applicable will be deducted as per rules/ otherwise you will have to submit income tax exemption certificate or income tax registration no. of your firm PAN No.

27.In case of difference of opinion, misinterpretation of any of the condition of the contract. In connection with or arising out of the condition or during the period work, the decision of the under signed shall be final & binding on you.

28. While execution of work, if any loss is caused to MSETCL, the same will be recovered from you & you will have to make good the loss, work to be attended by you at your cost & risk only.
