- 1) Due Date:** - The quotations complete in all respects i.e. **offer rates should be filled in given work Schedule "A" format** copy duly signed, sealed & super scribed, **along with covering letter of bidder/agency with above mentioned subject** shall be submitted to this office on or before Dt. **20.03.2025** up to **13:00 Hrs** positively **Date of Opening:- 21.03.2017** on 15:00 Hrs if possible.
- 2) Scope:** - As detailed in schedule 'A'.
- 3) Quoted Rates:** - The quoted rates should be inclusive of all Taxes & Charges as per specification/ for work mentioned in Schedule "A". If not mentioned it will be considered inclusive of all taxes & charges.
- 4) Time of contract** The time will be reckoned from the date of actual commencement/hiring of the L.M. vehicle. The contract period will be from 01.04.2025 to 31.03.2026.


