TERMS & CONDITIONS:

- 1. DUE DATE: The quotation completed in all respect, duly sealed & super scribed quotation should be submitted to this office either in person/post on or before Dtd. 17.03.2025 upto 18:00 Hrs positively.
- 2. ESTIMATED COST: The estimated cost is limited upto Rs 20, 700/- including of all.
- 3. QUOTED RATES: The quoted rates should include the cost of all taxes. The taxes will be clearly mentioned, & if the taxes are not clearly mention, then it will be presumed that the rates are inclusive of all taxes.
- 4. VALIDITIY OF OFFER: The offer should be valid for acceptance for a period of 90 days form the due date of same.PAN CARD should be attached with quotation.
- 5. **GST:** The prevailing rates of the GST will be applicable to this order.
- 6. Taxes as applicable will be deducted from your bill at source.

- 11. PRICE:- The rates quoted should be firm & price variation will not be applicable at any cost.

- 12. **EXECUTION OF WORK:** In the event of the offer being accepted in the whole, the successful contractor shall execute the order immediately as per the order schedule within the time specified in the work order.
- 13. **INCOME TAX & OTHER TAXES:** Income tax & other taxes as applicable as per the rules & prevailing rates will be deducted from the contractor's bill at source.
- 14. TRANSFPORTATION: The necessary To & Fro Transportation is in the scope of MSETCL.
- 15. BILLS: You will have to submit the bills in triplicate to this office as per the specifications mentioned in Schedule 'A'. The bills submitted should be in the name of Office of the Superintending Engineer, EHV O&M Circle, Karad. Please quote your GST No. & SAC Code for the Service availed by you on bill for smooth payment.
- 16. PAYMENT: 100% payment against the bills for the work actually carried out will be given to you after deducting necessary taxes & duties as per Govt. Rule either by cheque or NEFT/RTGS.
- 17. **PENALTY:** If the supply is not completed within the stipulated time period the penalty will be charged as per prevailing rate i.e.1% of the order value per week of delay maximum upto 10% of the total order value.
