Sub: Locking/disabling R&M Budget-Revised Estimates (RE) 2024-25.

As per Circular No. 1882 dated 19.03.2024, the R&M budget for FY 2024-25 was circulated and sanctioned under BR 167-06 dated 04.04.2024, amounting to Rs. 692.93 Crores. However, the approved Repairs & Maintenance (R&M) expenses for FY 2024-25, as per the MERC approval MYT Order 232 of 2022, are Rs. 466.42 Crores. Accordingly, the RE budget for FY 2024-25 has been allocated to each zone and the same is to be putup for approval in ensuing Board meeting.

As of 12.03.2025, it has been observed that the R&M expenditure booked stands at Rs. 551.4 Crores, exceeding the budget allocation of Rs.466.42 Cr. as per MYT order 232 of 2022. In light of this excess booking, it is instructed to all zones not to do any further booking under R&M budget. The IT section at Corporate office has been directed to block/disable the GL and movement type to prevent any further R&M bookings across all field offices.
